Check box when complete	REQUIRED DOCUMENTS – Paper or plastic copies must be provided. We cannot accept any of these documents from an electronic device. ALL DOCUMENTS SHOULD BE FILLED IN AND SIGNED AS REQUIRED BY THE FORM.	
	1	Student's valid permit (NOT EXPIRED)
	2	Driver Education Course Completion Certificate – REQUIRED FOR AGES 18-24, optional for ages 25 & above * "ADE" form from 6-hour course used to get permit. <i>The title of the form should be: "Texas Adult Driver Education Certificate" – "DRIVER EDUCATION COURSE EXCLUSIVELY FOR ADULTS"</i>
	3	ORIGINAL - "Impact Texas Young Driver" (ITYD) video certificate * Must be dated within 90 days of the testing date (expiration date should be displayed on certificate) * Click here to link to access the video. IMPACT TEXAS YOUNG DRIVERS VIDEO
	4	Texas Liability Insurance Card for car driven in the Road Test (SEE ADDITIONAL REQUIREMENTS IN THE SECTION BELOW) * Insurance card must show current effective dates, cannot be expired * NO ELECTRONIC COPY ACCEPTED (MUST BE PRINTED COPY) * The VIN # on the insurance card must match the VIN # on the registration sticker AND the car itself * Car must be listed on the liability insurance card and the student cannot be listed as an excluded driver
Check box when verified	CAR INSPECTION - Texas State Law requires these items to be inspected on the car before the test can be administered.	
	1	Current Non-Expired Registration Sticker on windshield * A new car with 1 non-expired Texas Buyer's PAPER License Plate on back and no registration sticker is ACCEPTABLE
	2	These items must be in working order * Working Horn * Working Brake Lights and Turn Signals * Seat Belts must be present and worn during test * At least one mirror must be intact (rearview or outside)
	3	Working Headlights, Tail Lights and Windshield Wipers * If current conditions require them at the time of the test
	4	Front Driver & Passenger Doors must be present and open from the inside & outside
	5	Proper License Plates * 2 Metal Plates - affixed to outside <u>on the bumper</u> - FRONT and BACK; OR * If it is a newly purchased vehicle, a non-expired, paper "Texas Buyer's Plate" is allowed on rear of the car
THESE FORMS ARE NOT REQUIRED FOR THE TEST AT GLDA - BUT THEY WILL BE REQUIRED AT THE DPS TO GET YOUR LICENSE		
1	DL-14A - Application for Driver's License – this can be picked up at the DPS office when you arrive
