	1	Student's valid permit (NOT EXPIRED)
	2	Driver Education Course Completion Certificate * "DE-964" form from Course provider. <i>The title of the form should be: "Texas Driver Education Certificate" – "FOR DRIVER LICENSE ONLY"</i>
	3	Copy of 30-Hour Instructional Driving Log(s) (completed by parents or other adult).
	4	ORIGINAL - "Impact Texas TEEN Drivers" (ITTD) video certificate * Must be dated within 90 days of the testing date (expiration date should be displayed on certificate) * Website for video: https://impacttexasdrivers.dps.texas.gov/ITTD/
	5	Texas Liability Insurance Card for car driven in the Road Test * Insurance card must show current effective dates, cannot be expired * NO ELECTRONIC COPY ACCEPTED (MUST BE PRINTED COPY) * The VIN # on the insurance card must match the VIN # on the registration sticker AND the car itself * Car must be listed on the liability insurance card and the student cannot be listed as an excluded driver
Check box when verified	CAR INSPECTION - Texas State Law requires these items to be inspected on the car before the test can be administered.	
	1	Current Non-Expired Registration Sticker on windshield * A recently purchased car with no registration sticker on windshield MUST have 2 metal license plates- affixed on the outside on the bumper – front & back AND a Texas Buyers Tag Receipt – Buyers Copy
	2	Proper License Plates * 2 Metal Plates - affixed on outside <u>on the bumper</u> - FRONT and BACK
	3	These items must be in working order <ul style="list-style-type: none"> * Working Horn * Working Brake Lights and Turn Signals * Seat Belts must be present and worn during test * At least one mirror must be intact (rearview or outside)
	4	Working Headlights, Tail Lights and Windshield Wipers * If current conditions require them at the time of the test
	5	Front Driver & Passenger Doors must be present and open from the inside & outside
THESE FORMS ARE NOT REQUIRED FOR THE TEST AT GLDA - BUT THEY WILL BE REQUIRED AT THE DPS TO GET YOUR LICENSE		
1	VOE (Verification of Enrollment) - this is provided by the student's school if under age 18	
2	DL-14A or DL14-B - Application for Driver's License – this can be picked up at the DPS office when you arrive
