	1	Current Non-Expired Registration Sticker on windshield * Car w/ Non-expired Texas Buyer's (PAPER) License Plate on back & no registration sticker is ACCEPTABLE	
	2	Proper License Plates * 2 Metal Plates - affixed to outside on the bumper - FRONT and BACK; OR * Car w/ Non-expired Texas Buyer's (PAPER) License Plate on back & no registration sticker is ACCEPTABLE	
	3	These items must be in working order * Working Horn * Working Brake Lights and Turn Signals * Seat Belts must be present and worn during test * At least one mirror must be intact (rearview or outside)	
	4	Working Headlights, Tail Lights and Windshield Wipers * If current conditions require them at the time of the test Front Driver & Passenger Doors must be present and open from the inside & outside
