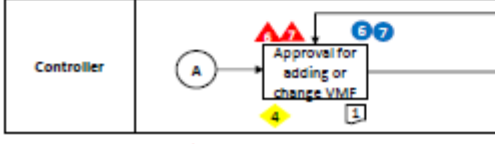
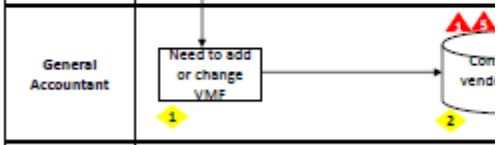
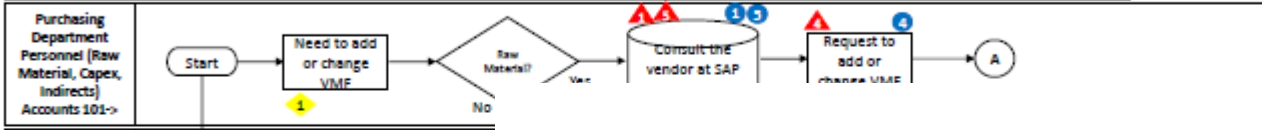

Description

- 1 During the normal course of operations there are needs to add or change the Vendor Master File and those are communicated through e-mail or phone call.
- 2 Authorized personnel may access and consult the vendor master file before requesting a new vendor.
- 3 When requesting an add or change to the vendor master file, the user need to complete a request form that would need to be approved by the Controller.
- 4 The Controller approve the add or change of the vendor master file based on the request form completed.
- 5 The General Accountant is the only person that may add or change information of the vendors at SAP R3 (i.e. adding a new account at the CoA for vendors).
- 6 The General Accountant is the only person that may add or change the vendor master file in SAP R3.

Risks

- ▲ Possibility that non authorized users may access to the VMF to read and consult vendors information.
- ▲ Possibility that non authorized users may access CoA for adding, changing, activating or inactivating GL accounts for the vendors.
- ▲ Possibility that non authorized users may access VMF at SAP R3 for adding, changing, activating or inactivating the vendors.
- ▲ Possibility that adding, changing, activating or inactivating the vendors in SAP R3 is not properly documented in the request template.
- ▲ Possibility that VMF at SAP R3 is incomplete with key fields empty and/or duplicate vendors due to lack of periodic maintenance.
- ▲ Possibility that new vendor and/or change in the VMF is not authorized by appropriate level of Management.
- ▲ Possibility of incorrect or incomplete information of new vendor and/or change in the VMF.
