Annual HOA Meeting and Board Elections

The Commonwealth Civic Association Annual Meeting is scheduled to take place on **Tuesday, May 19, 2020 at 7 p.m.** in The Commonwealth Clubhouse. Two Director positions will be placed on the ballot this year.

That being said, at the time of this writing, we are still in quarantine with no definitive end in sight.

If you are on the Email Alert List, you will have received updating emails to let you know if and when any changes have been made.

Annual meeting notices (and a proxy ballot) will be mailed in time for the meeting (whenever that may happen) and the Board will meet to determine how to proceed with the business that needs to be addressed.

Residents in good standing with the HOA will be permitted a vote on each Director's position. Proxies may be mailed in advance or residents may vote in person on the evening of the election.

The two directors up for re-election are Sumita Ghosh and Rajeev Somani. Board members will vote on board leadership positions at the first board meeting held after the Annual Meeting.

Expectations of Board members include but are not limited to:

- ❖ Attend a minimum of one monthly meeting (on the 4th Thursday of each month)
- ❖ Act as a liaison to one or more of the committees in the community
- ❖ Be assigned to oversee one or more aspects of the community. For example: landscape, parks, pools, tennis courts etc.
- ❖ Attend two or more meetings of the Modifications Committee in order to understand the role and operation of the committee
- ❖ Be available to volunteer at Community Events
- ❖ Be able to check and respond to community specific emails with the rest of the Board and Management Company at least every other day.

We hope all residents will make an attempt to attend the Annual Board Meeting. Association goals and objectives will be discussed in depth. Reports will be given.

The Census is STILL Coming!!!!

The 2020 Census deadline was extended due to the pandemic.

In March each household received an invitation in the mail to share the requested information. You were offered the option of responding online, by mail, or by phone. This invitation was followed up by mail several times if you did not comply.

If a response is not received, this summer a census taker will make a trip to your home to speak with you.

Information collected in this questionnaire determines how much money local governmental entities receive, helps establish where businesses open and how political districts are drawn. This information is critical to our future.

If assistance is required, in filling out the form, operators are available to those who ask. The number is on your questionnaire.

Sadly, at this time our projected pool opening will have to wait until restrictions are lifted. Lifeguards must still be hired and trained and this cannot happen until life returns to "normal". Naturally, we are unable to open until we have enough lifeguards to be fully staffed for each shift and we are assured that the lifeguards have been well trained.

If lifeguards in training have to wear N95 masks, all industry experts and training agency medical advisors believe that we should not be operating or training lifeguards with that restriction in place.

We may be forced to open only one pool to start the season. The number of lifeguards that can be hired will also affect the pool hours.

If any government, CDC or other guidelines are placed on our facilities that are in addition to the current operating procedures, these guidelines and procedures could cause further delays.

Proposed 2020 POOL SEASON

Pool tags will be issued to any homeowner that is in good standing with the Association. To obtain pool tags, go to www.crest-management.com and complete the pool registration form on the home page. Pool tags will be mailed to residents upon receipt and verification of the request form. Registration and pick up of pool tags in person at Crest Management's office will incur a \$20 charge.

Pool tags **will be checked** by management personnel when entering the pool facility. If a tag is not in the resident's possession or cannot be verified, residents and/or others may be asked to leave the facilities. Only residents with a valid pool tag will be allowed into the pool (with exception of prearranged pool parties through the pool company). **Each pool tag allows 2 guests.**



This step is being taken to ensure that only Commonwealth residents and their guests have access to our courts and encroachers are displaced.

Is It Time To Replace Your Fence?

Every Residential Property must have a perimeter fence. All proposed replacement, relocation and/or changes from original as installed by builder/developer must have Modifications Committee approval.

All fences, gates, walls and hedges must be maintained in good condition.

This includes but is not limited to: trimming hedges; replacement of rotted, missing, broken or warped wooden pickets; repair or replacement of leaning fence sections; repairing/replacing metal fences where paint is faded, peeled and/or where rust has formed.

Minor repairs must be made with same materials and construction details used in original.

No chain link, chicken wire, or lattice type fence construction will be permitted on any lot.

Fences are not to be built or altered, in any form or fashion, to incorporate any artistic designs, cutouts, initials, symbols or other "decorative" elements.

No fence, wall or hedge may extend so as to encroach across the recorded front building line or the recorded front building

line of an adjacent house, and may never extend beyond the actual front building line.

No new fence shall extend beyond any side building line adjacent to a street.

Replacement of perimeter fences should align with and match overall height (6') of neighboring and adjacent fences.

Both neighbors sharing a lot line must concur as to a proposed fence, wall or hedge extension on their common lot line. If both neighbors do not concur as to a proposed fence, wall or hedge extension, the Modifications Committee will examine the effect the extension will have on both properties. If one party will suffer detrimentally from the extension (such as a existing site line will be blocked) the Modification Committee may reject the application. Lot line fence, wall or hedge extension must not obstruct neighbor's view or access to or use of their property.

Fence requests are subject to the Covenants, Conditions and Restrictions for Commonwealth. Some neighborhoods have Supplemental Restrictions which may supercede these Architectural Control Guidelines.

REMINDER -- Please put trash cans (and recycling bins) at the curb on the morning of trash pick up days no earlier than 6 p.m. on the day prior to pick up. This also applies to lawn debris. If your landscape company habitually leaves grass and tree cuttings in front of your home each week, ask them to start taking it with them.
