CW Pool Tags

Pool tags will be issued to any homeowner that is in good standing with the Association.

To obtain pool tags, go to <u>www.crest-management.com</u> and click request a pool tag/access device on the home page.

Pool tags will be mailed to residents upon receipt and verification of the request form.

There will be a \$20 expedite fee to pick up pool tags in person at Crest Management's office.

Pool tags will be checked by management personnel when entering the pool facility. If a tag is not in the resident's possession or cannot be verified, residents and/or others may be asked to leave the facilities. Only residents with a valid pool tag will be allowed into the pool.

Trash Talk

We have received complaints from residents regarding trash pickup in the community.

If your trash is **NOT** picked up as calendared, please call Republic and let them know. If you email, copy the HOA.

As a reminder, Republic will NOT pick up your green waste unless it is in a clear bag. This is NOT an HOA rule, Republic has defined the rules of engagement!

Green Waste

Green waste pick up service is provided once a week and is recycled into mulch.

Green waste includes:

- Grass clippings
- Leaves
- Brush
- Tree limbs
- Christmas trees (ornaments and lights removed)
- Organic material produced in your yard or garden
- Does not include food waste or treated wood.

Program Guidelines

- Set your green waste out by 7 a.m. on your collection day but no earlier than 6 p.m. the evening before. No more than 10 cubic yards will be collected.
- Loose materials such as grass clippings and leaves should be placed in a reusable container or in bags and tied. Clear or translucent bags are required. Compostable bags are not required.
- If a reusable container is used, it needs to be removed from the curb no later than 8 a.m. on the morning following the day of collection.
- Brush and tree limbs must be less than 4 inches in diameter and less than 4 feet in length; or between 4 and 6 inches and less than 2 feet in length.
- Brush and tree limbs must be stacked in small piles (3 feet high and 3 feet wide). Bundling of tree limbs is not required, but recommended.
- Green waste should be set out at the curb at least four feet from other objects.
- Do not place green waste in your city issued garbage or recycle cart.
- If you have a lawn care professional tending your yard, please request that they service your yard the day prior to your collection day.

Guidelines for Landscapers

Landscapers are asked to follow specific guidelines as it relates to their work. See the Landscaper Green Waste Guidelines Brochure for additional information for landscapers.

Bulky Waste

Bulky waste service is provided on a **flexible on-call basis**. The service allows residents to schedule 12 bulky waste collections per year by contacting:

Republic Services Customer Service at 713-726-7307 or via email at sugarland@republicservices.com.

- The City offers 3 additional bulky waste collections following the Thanksgiving, Christmas, and New Year's holidays at no additional cost.
- Additional bulky waste collections are available for a fee.
- Fees must be paid prior to scheduling the service. Guidelines
- Set bulky items out by 7 a.m. on collection day but no earlier than 6 p.m. the evening before.
- Residents may place up to five cubic yards of bulky waste out for collection on their bulky waste service day.
- Bulky items should be set out at the curb at least four feet from other objects.
- Do not place items in garbage carts for bulky waste collection. Items should be placed directly at the curb.

Landfill Drop-offs

Residents also have access to free landfill drop-offs at Blue Ridge Landfill - 2200 FM 521 Road, Fresno, Texas.

The landfill accepts household solid waste items from 4 a.m. to 5 p.m. Monday through Friday and from 5:30 a.m. to 12:00 p.m. Saturday.

- Residents are allowed one free visit a month to dispose of up to 3 cubic yards
- Visitors are required to provide a valid driver's license and utility bill upon entry
- All visitors will be required to wear a hard hat and safety vest.

Garbage & Recycling Guidelines

Automated garbage service is provided twice a week. Recycling service is provided once a week.

Standard garbage service utilizes a 95-gallon grey cart and recycling utilizes a 65-gallon green cart.

YOU HAVE A SERVICE DAY, NOT A SERVICE TIME.

On your collection day, set your carts out by 7 a.m., but no earlier than 6 p.m. the evening before.

When taking out your garbage and recycling carts, remember:

- Ensure all materials fit in the cart. Only items placed inside the cart will be collected.
- Always keep the lid shut.
- Carts should be placed at the base of the curb (where curbs exist) with the cart wheels against the curb.
- Cart handles should be facing away from the street. Lids should open to the street.
- Carts should be placed at least three feet apart to ensure the collection truck can service both carts.

After your collection takes place:

- Return your carts to your property no later than 8 a.m. on the morning following the day of collection.
- Carts must be stored on your property, in compliance with deed restrictions. Do not store your cart in the alley or on the street.
- The cart remains the property of the City of Sugar Land. It is yours to use while participating in the program. If you move, leave the cart at the residence.

RECYCLING TIPS

- Please follow guidelines on items that are allowed in the cart and only recycle acceptable materials.
- All recyclable materials may be mixed together inside the cart.

- Plastic bags are not allowed in the recycling carts.
 - Place loose materials in your cart.
- Protect recyclables from inclement weather by keeping the lid closed.
- Ensure that you flatten and cut cardboard to fit in your cart. Make sure cardboard does not get jammed in your cart prohibiting it from being emptied.
- Maximize space in your cart by crushing plastic bottles and aluminum cans, and cutting boxes down.
- Ensure that all your cans and bottles are empty before recycling them to avoid contamination of other materials.

Textile Recycling

Donate First, Recycle Second

This program will target the textiles going into landfills, not items being donated to charities, churches, non-profits and other organizations. The City encourages residents to donate items to a local charitable organization.

What can be recycled?

- Bedding
- Clothing
- Coats & Jackets
- Curtains/Draperies
- Fashion accessories
- Halloween Costumes
- Handbags & Purses
- Hats & Gloves
- Linens
- Pet Beds & Clothing
- Pillows
- Shoes, Sandals & Slippers
- Sleeping Bags
- Stuffed Animals

- Call Green City Recycler at 832.989.2745

Preparing for a pickup

- Textiles must be placed in a customer-owned container (bag or box).
- Set your textiles out on your front porch by 7 a.m. on your collection day, but no earlier than 6 p.m. the evening before.
- Do not place textiles in your city issued recycle cart.

Water Leaks

From the City of Sugar Land:

An unusually high water bill could be the result of a leak somewhere on your property. If you received a high water bill due to a leak and have fixed the leak, you might qualify for an adjustment on a future bill.

- □ Leak adjustments are limited to one per rolling twelve-month period and per customer.
- □ If you qualify, up to two consecutive billing periods affected by the leak may receive an adjustment.
- It may take up to two billing cycles before the adjustment will be applied as a credit to the utility
- ^{II} The adjustment will be calculated using the previous twelve (12) month's bills (excluding high bills due to the leak).
- If the high water bill occurs during the calculation of winter quarter average, your winter average will be recalculated and your next bill adjusted accordingly.
- □ A maximum adjustment of \$2,500 will be applied per qualified customer.

There will be NO City of Sugar Land Council elections on the ballot.

FBISD Bond Referendum

Fort Bend ISD voters will get to decide on the largest bond in the district's history this May.

Fort Bend ISD's board of trustees voted to call an election for a nearly \$1.26 billion bond.

The \$1.18 billion **Proposition A** encompasses construction, security and transportation upgrades, along with a \$19.2 million transportation facility. **Proposition B** would cover nearly \$52.5 million for technology updates, and the \$22.9 million **Proposition C** would fund a new district natatorium.

The bond election will be held during the 2023 general election on May 6.

Fort Bend Transit Mobile Ticketing Is Now Available

Fort Bend Transit (FBT) is excited to announce the launch of its mobile ticketing option in collaboration with Token Transit. Mobile tickets, known as "passes", are available through the Token Transit app, which can be downloaded for free.

Mobile passes are available in Token Transit's digital app that can be downloaded from Apple's App Store, Google Play, or Token Transit's website at www.tokentransit.com.

Individual passes and bulk passes, similar to physical ticket books, are offered for all current Commuter Park and Ride routes and for the Demand Response service. The cost for mobile passes remains the same as the corresponding physical ticket option. Fare information can be found on FBTs Fares webpage at www.FBCTransit.org.

The implementation of mobile ticketing is a continuation of FBTs efforts in providing convenient, affordable, reliable and safe transportation. The Token Transit app's high download and usage rate within the first few hours of its launch demonstrates FBTs ability to listen to its riders while simultaneously responding effectively to their requests.

FBT offers two public transit services: Commuter Park and Ride and Demand Response.

There are three Commuter Park and Ride lot locations:

- ♦ Fort Bend County Fairgrounds in Rosenberg
- ♦ University of Houston Sugar Land
- ♦ First Colony AMC Theatre

Commuter service includes morning and evening schedules. Commuter Service operates during peak hours Monday through Friday, excluding County acknowledged holidays, with routes starting as early as 4:30 am and ending as late as 9:00 PM.

FBTs Demand Response service is a curb-to-curb, shared ride service for the citizens of Fort Bend County. The scheduled ride transportation service provides trips within Fort Bend County. Information on booking a trip can be found on FBTs Services webpage at www.FBCTransit.org.

About Fort Bend Transit

In 2005, the Fort Bend County Commissioners Court approved the creation of the Fort Bend County Public Transportation Department (FBCPTD) to serve the general public in Fort Bend County. The purpose of FBCPTD is to provide seamless service between urban and rural communities; access rural transit funding and increase services to residents in Fort Bend County without increasing a financial burden to the taxpayers. As of June 14, 2021, FBCPTD is known as Fort Bend Transit, or FBT. FBT's mission is to provide safe and efficient public transportation services while maintaining service quality and customer satisfaction.

Briarwood Splash Pad News!

The splash pad located next to the Briarwood pool has been recently gated to separate it from the pool so that Commonwealth residents can use the splash pad outside of the pool season. A door was also added on the side of the pool building to allow access to the restroom for families at the park or splash pad. Both the splash pad and exterior pool restroom can be accessed by requesting a splash pad access card.

PLEASE NOTE:

- Access to the restroom during pool hours will be through the main pool entry gate.
- Access to the exterior restroom when the pool is closed can be obtained with this access card. The restroom will be accessible from 8 a.m. until 9 p.m.
- The splash pad will be open each year from March 1st- October 31st from 8 a.m. until dusk.

- The posted rules at the splash pad must be followed.
- If the restrooms need cleaning or attention, please contact Ronald with Crest Management (contact info below).
