



LIQUID LOVE CLUB MEMBERSHIP AGREEMENT

This Liquid Love Club Membership Agreement (“Agreement”) is entered into between BWS Enterprises, DBA Black Wall Street Liquid Lounge (“Liquid Lounge”) and the undersigned member (“Member”).

1. MEMBERSHIP TERM & FEE. The Liquid Love Club is a three (3) year membership commitment. Membership is billed annually at \$250 per year, for a total commitment of \$750 over three years. The Member agrees to maintain membership for the full three-year term, subject to the terms of this Agreement.

2. MEMBER BENEFITS. During an active membership, the Member is entitled to the following benefits: (a) one bag of whole coffee beans or ground coffee per month; (b) 10% off eligible food and beverage purchases at Black Wall Street Liquid Lounge; (c) one complimentary private event—subject to availability and the Liquid Lounge’s event policies—and tiered discounted rental rates for subsequent private events; and (d) complimentary use of small conference room one time per month, subject to availability and applicable scheduling policies. [Note: Membership must be paid in full for the applicable annual membership period, and the member must have maintained active membership for at least two months before the member may use benefits (c) and (d). The complimentary private event and monthly conference room benefit are subject to availability, advance reservation, reasonable usage policies, and any applicable event or room rules established by Liquid Lounge.]

3. MEMBERSHIP POLICIES. Membership benefits are personal to the Member and may not be transferred, sold, or exchanged for cash. Unused monthly benefits do not accumulate or roll over unless otherwise approved by Liquid Lounge. Discounts may not be combined with other promotions or discounts unless expressly authorized by Liquid Lounge. Liquid Lounge reserves the right to establish reasonable rules regarding scheduling, availability, capacity, food and beverage service, private events, conference room use, and other membership benefits. Membership benefits may be modified or discontinued (if necessary) due to changes in operations, provided such changes do not materially alter the Member's core membership commitment.

4. CANCELLATION & DEFAULT. Because the Liquid Love Club is a three-year commitment, the Member agrees to fulfill the financial obligations associated with the membership term. Failure to pay an annual membership fee when due may result in suspension or termination of membership benefits. Any cancellation, refund, or early termination will be subject to the policies of BWS Enterprises and applicable law.

5. ACKNOWLEDGMENT. By signing below, the Member acknowledges that they have read, understand, and agree to the terms of this Agreement, including the three-year membership commitment, \$250 annual fee, and two-month waiting period before using the complimentary private event and conference room benefits.
