## Ex-Black Liberation Army member convicted of killing two cops in 197 up for parole.

A former Black Liberation Army member convicted of killing two cops at a Harlem housing project more than 45 years ago is up for parole again. A parole hearing for Herman Bell is scheduled for next month, state officials said. The convicted cop killer has been in prison since 1979. Diane Piagentini, the widow of one of the officers killed by Bell, will give the parole board an impact statement over the telephone. Bell, Anthony Bottom and Albert Washington ambushed Officers Joseph Piagentini and Waverly Jones after luring them to the Colonial Park Houses — now the Rangel Houses — on W. 159th St. with a bogus 911 call back on May 21, 1971. Anthony Bottom has a parole hearing set for June. Washington died in prison.

Recently in the news it has been reported that the last outpost and a great place for cops and the neighborhood to gather and raise a pint "COOGAN'S," is closing down after over 30 years. It's been reported that New York Presbyterian Hospital owns the space and has raised the rent to \$40,000 a month. The beloved Washington Heights bar and restaurant that was set to close will stay open, with help from the community and pressure from elected officials.
