He passed away at age 95. Survived by his wife Artherine, whom he met while he was a training as a pilot and while she was part of the All-female crew that repaired planes. The RDNY salutes you. ## **APRIL MEETING:**

Honorees and former partners, Police Officer **Ryan Nash** of TARU and Police Officer **John Hasiotis** of the MidTown South Peddler Unit. While assigned to the 1st precinct, on the afternoon of October 31, Halloween Day 2017, a terrorist who hailed from Uzbekistan rented a pickup truck in New Jersey and headed south. At the corner of West and Houston Streets, he entered the bike lane and over a period of four minutes ran down pedestrians and bicycle riders, killing 8 and injuring many more. Initially, Officer's Ryan Nash and John Hasiotis, had been summoned to help with a student who was in the nurse's office at 345 Chambers Street who had indicated that he wanted to kill himself. But after the terrorist (Saipov) crashed his truck into a school bus and ran into the streets, the officers darted to the scene, into the streets, coming face to face with Saipov, who appeared to

be toting a weapon. That's when Nash opened fire, shooting Saipov in the abdomen. The Terrorist was quickly restrained by Police Offer John Hasiotis and others.

A prime example are the cases that have been overturned and defendants being given million dollar settlements. 
