The cost-of-living adjustment (COLA) for September 2018 through August 2019 benefit payments is 1.2%.

As a result, an eligible retired member with an annual pension of \$18,000 or more will receive an increase of \$18 per month beginning with the September 2018 payment. (Eligible members receiving an annual benefit under \$18,000 will receive a lesser monthly increase.)

By law, the COLA can be no less than 1% and no more than 3% annually and is applied only to the first \$18,000 of the retirement benefit. The COLA percentage is calculated by taking 50% of the Consumer Price Index (CPI) increase from one March to the next and rounding up to the nearest tenth. The CPI increased 2.36% from March 2017 to March 2018.

COLA Eligibility

To be eligible for a COLA, you must either be:

- At least age 62 and retired at least five years; or,
- At least age 55 and retired at least 10 years; or,
- A retiree receiving a LOD disability benefit for at least five years (regardless of age); or,

• A surviving spouse of an eligible retiree receiving a lifetime benefit. (By law, the spouse receives an increase equal to one-half the COLA the retiree would have received). Retiree's who become eligible for the COLA after September will receive their adjustment when first eligible. This latest COLA will bring the cumulative maximum monthly increase since COLA legislation was enacted in 2001 to \$348.
