**2020 BBQ COOK-OFF RULES**

1. YOU MAY ARRIVE ANYTIME FRIDAY MORNING. ALL SPOTS WILL BE ASSIGNED. *(PLEASE LET US KNOW IF YOU REQUIRE A SPACE FOR A RV.)*
2. TEAMS WILL PROVIDE ALL THE EQUIPMENT NEEDED TO COOK IN THE CONTEST.
3. ELECTRICITY WILL BE PROVIDED. WATER HYDRANTS ARE AVAILABLE. DEDICATED CIRCUITS ARE NOT AVAILABLE.
4. TEAMS ARE REQUIRED TO KEEP THEIR AREA CLEAN AND PICK UP TRASH BEFORE LEAVING.
5. NO ALCOHOLIC BEVERAGES ALLOWED.
6. FIRES CAN BE OF WOOD, PELLETS, CHARCOAL, OR GAS. PLEASE DO NOT DUMP CHARCOAL OR WOOD ON GROUND.
7. NO FIRES ARE ALLOWED ON THE GROUND, BARREL FIRES ARE OKAY. CHIMNEYS NOT TO BE ON GRASS.
8. ALL MEAT MUST BE IN RAW CONDITION, NO MARINADE OR SPICE CAN BE DONE OF ANY KIND UNTIL MEAT HAS BEEN INSPECTED.
9. NO PARBOILING OR DEEP FRYING COMPETITION MEATS.
10. SAUCE OF ANY KIND MAY BE USED. NO POOLING OF SAUCE OR DIPPING CUPS IN BOXES.
11. TURN IN BOXES MUST HAVE AT LEAST 6 PIECES OF MEAT FOR JUDGING, YOU CAN PUT MORE BUT MINIMUM OF 6 PIECES REQUIRED IN BOX.
12. CHICKEN MAY BE WHITE OR DARK MEAT AT LEAST 6 PIECES IN A BOX.

13. RIBS MUST BE DONE IN AT LEAST 6 PIECES ALSO. RIBS MUST BE BONE IN. NO COUNTRY STYLE RIBS ALLOWED.
14. PORK CAN BE CHOPPED, SLICED, OR PULLED AND AT LEAST ENOUGH FOR 6 SERVINGS TURNED IN.
15. DO NOT MARK ANYTHING ON THE BOX THAT WILL BE GIVEN TO YOU FOR TURN IN.
16. CONTESTANTS MAY NOT SELL BBQ DURING THE EVENT.
17. THIS CONTEST IS RAIN OR SHINE.
18. BOXES FOR TURN IN WILL BE FURNISHED.

**TURN IN TIMES ON SATURDAY WILL BE:**

CHICKEN	12:00 PM
RIBS	12:30 PM
PORK	1:00 PM
ANYTHING BUTT	1:30 PM

- You will have the standard turn-in time – 5 minutes before and 5 minutes after on each meat. For instance, chicken can be turned in from 11:55am – 12:05pm. Once time is up, no more entries will be accepted for the category. Please don't be late!
- Garnish is allowed. Please read carefully on what you can and cannot use. Do not put anything in the turn-in box other than what the rules tell you. Only green leaf lettuce, parsley and kale can be used. Do not dress the box with anything else, not even a toothpick. We will provide a 9x9 styrofoam box.
- A Quick cook's meeting will be held at 4:30pm on Friday Evening followed by wings & People's Choice. We will try to have awards ready by 2:30pm on Saturday.

- The Deadline for sign-up is **May 30, 2020**. Check or money order must be turned in by **June 6, 2020**. Entry Fee of \$150 covers all four (4) meat categories. \$20 for wing contest.

## **ANYTHING BUTT RULES (PROTEIN MUST BE A MEAT OR SEAFOOD)**

1. Entry shall be anything other than KCBS Chicken, Pork Ribs or Pulled Pork
2. If cooking, the heat source used and method is up to the cook's discretion.
3. Components may be prepped prior. All cooking and assembly must be done on site.
4. Turn-in may be in or on any container, tray or platter no larger than can be easily carried by one person (e.g. 18" x 24").
5. KCBS garnish rules DO NOT apply.
6. Entry must be sufficient to provide samples for six (6) judges.
7. If entry requires slicing or serving, team must provide knife or spoon to do so. Plates, bowls, cups, etc. must also be provided by the team.
8. Any questions regarding rules will be addressed by the contest organizer on Friday and Saturday at the venue.

## **WINGS CONTEST ON FRIDAY NIGHT**

1. Benefiting OUR FATHER'S HOUSE (a cold weather shelter for the homeless).
2. \$20 Entry Fee.
3. Fifteen (15) lbs of wings will be provided.
4. Turn-in at 6:45pm Friday night.
5. The wings will be judged by the public and team with the most money in their jar will receive a plaque and \$100.

## **PEOPLE'S CHOICE**

1. A butt will be provided.
2. Turn-in will be at 10:45am Saturday morning.
3. Judging will be done by the public.
4. Winner will receive a plaque and \$100.
