As of 12/1/2022: \$9168.70 Balance. \$2500 of that was spent on the anniversary and special events for the 50th anniversary year. Kim has cleaned up our books over 3 years and balanced the books and found some discrepancies.

Budget this year is \$15,903.99, we will carry over somewhere between \$1000-1500 for next year.

Becky asked about the notes at the bottom of the budget, Robyn forfeited her \$250 gift last year and this year. Kim cleaned up the discrepancies and Robyn is able to receive her gift for both years.

Committee Chair Reports:

Ringers - Bobbie Elbert report received

84 recorded Ringer Cards are in the box to date. That is the total we ended with last season. There will be more. To ensure the accuracy of this contest, ringer recordings are checked every week. Common errors are putting the score in the wrong box (3 on #6, instead of 3 on #7) and putting someone else's score from your tee group into your card (using score of player on the line above you).

Will likely end the year close to 90 recorded ringer cards. It's important that the members completely fill out the cards to avoid the common mistakes.

Had an average of 43 players. 90 players have played at least one time. 3 have perfect attendance: Paula Hodges, Pam Grimm, and Tarra Curtis. There are 5 who are missing only 1 day.

58 have qualified for the tournament.
