## MAYOR'S REPORT

Mr. Pecht stated the audit was good, he thanked FY 2024 Treasurer, Mrs. Johnson, Mrs. Lewis, and staff. Ms. Williams asked if the state required a minimum reserve for the audit, per Mr. Pecht, no legal reserve is set by the state. On the motion by Mr. Pecht, seconded by Mrs. Talbert and carried by all ayes.

## WASTEWATER REISSUANCE VPDES PERMIT UPDATE

# RESIDENTIAL ANTI-DISPLACEMENT AND RELOCATION ASSISTANCE PLAN CERITIFICATION ADOPTION

The certification for the 24-03 Town of Lawrenceville Park Street Community Development Block Grant Project is in the packet and Mr. Lynch is requesting council to adopt and Mayor Tatum to sign and execute the plan certification for DHCD. On the motion by Mr. Pecht, seconded by Mrs. Talbert and carried by all ayes.

# PARK STREET-HIGH STREET NEIGHBORHOOD PROJECT WATER AND SEWER RESOLUTION ADOPTION.

The resolution is in your packet and is to be included in the Park Street Phase II Neighborhood Infrastructure Project Grant application, this is broken into 2 phases, infrastructure, first phase. Mr. Lynch is requesting the Council adopt and authorize Mayor Tatum and the Town Manager to sign and execute the Park Street Neighborhood Project Water and Sewer Resolution as presented. On the motion by Ms. Grimes, seconded by Ms. Hardy and carried by all ayes.

## TOBACCO HERITAGE TRAIL RAMP PROJECT UPDATE

The Town submitted the SEID application to help with gap funding for this project, the town is awaiting grant application status. The pre-bid conference was held August 5, 2025. The bids can be received until August 19, 2025 at 2:00 p.m., will see the actual numbers at that time.

# TTHM & HAA5 TREND UPDATE

Mr. Lynch provided the charts to identify the TTHM and HAA5 testing results for all three systems. The results for 2025 testing continue to improve compared to the 2024 test results. Mr. Pecht asked if there is an average for compliance, Mr. Lynch explained a 5-test cycle, within a 4-month time frame. All numbers are lower, which is good.

# VML ANNUAL CONFERENCE SCHEDULE

Mr. Lynch provided the conference schedule in the packet and invited all council to attend, please let the office staff know if you are able and they we sign you up. Mayor Tatum stated the last day of the conference is on the regular council meeting date for October 2025, she wanted to make all aware.

# PUBLIC HEARING #2 FOR PARK STREET PHASE II

Presented in the add packet is the flyer for the public hearing #2, a meeting to be held on August 14, 2025 at 6:00 p.m. in the Town of Lawrenceville meeting room.

Mayor Tatum asked what, if anything could be done by the Town in reference to vacant/damaged buildings with-in the Town. Mr. Lynch explained that would fall under Building Code Enforcement; great expense, possibly look at grants available.

## FINANCE COMMITTEE

Mr. Pecht referenced the 2024 Audit and stated preparation is near for the current FY audit.

### FIRE AND EMERGENCY SERVICES

In the month of July 2025, The Lawrenceville Volunteer Fire Department responded to Fourteen (14) calls. Of the total, three (3) were in the town limits, eleven (11) were outside of the town limits. Also of the call total, eleven (11) were within Lawrenceville Fire's 1st Due, with three (3) being mutual aid to other agencies. Approximately, ninety-eight (98) man hours were expended. The following is a breakdown of incidents. Arcing Electrical Equipment (2), Disregard (1), False Alarm (1), MVC w/ injuries (2), MVC w/o injuries (1), Public service (1), Structure Fire (2), Tree Down (2), Vehicle Fire (2).

Chief Clary and Ms. Hardy spoke on grants available to possibly purchase tasers and cameras for police cars/units. Ms. Williams stated that traffic has slowed down tremendously on Windsor Avenue, she thanked Chief and officers.
