He attended the ribbon cutting at the Lake Country General Store and thanked Chris Baird and his family for their investment in the community. Mr. Outten reported that the Emergency Ordinance adopted by Town Council on April 14, 2020, and re-adopted on June 9, 2020, will expire unless readopted by Council. Mr. Outten recommended that Town Council readopt the ordinance and extend it for another sixty days. It will allow Council to meet by electronic means if needed during the ongoing COVID 19 pandemic. REPORT OF TOWN MANAGER

VPDES PERMIT

Mr. Gibson reported that DEQ has approved the VPDES permit for the wastewater treatment plant. It is a five year permit and it is effective on September 1, 2020.

CABOOSE UPDATE

T.J. Gaffney with Streamline Historic Services has not been able to get to town to inspect the caboose. He is still expected to inspect it and provide an estimate on restoration.

CURRENT SIDEWALK PROJECTS

Tobacco Heritage Trail/Gazebo Sidewalk – The bids came in higher than the VDOT estimates. The project will have to be re-bid.

CARES ACT COVID-19 RELIEF FUNDS

Mr. Gibson reported that he will get prices to purchase computers and other IT equipment for the meeting rooms. This would enable all of Council to meet electronically if necessary during the pandemic. The equipment would also be used for training purposes.

ST. PAUL'S COLLEGE CAMPUS RE-USE PROJECT

Mr. Gibson asked Dr. Woolridge to report on the project. Dr. Woolridge reported that the consultants provided six subject areas for repurposing the college property. The consultants are now exploring funding opportunities. That study should be completed in two to three weeks. Mr. Pecht and Mr. Gibson are the Town's representatives on the St. Paul's College Task Force. The Task Force meets on the first Thursday of each month at 2:00 p.m. Mr. Pecht commented on the tall grass on the property.

ALBERTA WATER SYSTEM INSPECTION

Ms. Prillaman with the Office of Drinking Water, Danville, inspected the Alberta Water System on August 6th.

OLD SOUTHERN STATES BUILDING

Mr. Gibson reported that he, Mayor Martin and Mr. Dotti inspected the Southern States building. The electricity has been off and the contents of the freezer had melted. Mr. Gibson requested permission from Council to have the electricity restored to the building. The condition of the building has been documented. The building needs to be cleaned and prepared for marketing. On motion by Mr. Brockwell, seconded by Ms. Hardy and carried by all ayes, Town Council voted to have the electricity service restored to the Southern States building. Motion: Mr. Brockwell. FINANCE COMMITTEE

PROPOSED BUDGET AMENDMENT

Mr. Pecht reported that the committee met. Two items are recommended to be amended in the budget: Revenue, Rural Development Grant, increase from \$0.00 to \$50,000 and Expense, Sewer, Hospitalization, increase from \$789.52 to \$52,193.40. FIRE AND EMERGENCY SERVICES

The July report is in the additional packet. The fire department responded to 17 calls in July. Of the 17, 3 were in the town limits and 14 were outside the town limits. Also, 10 were in the LVFD First Due area, with 7 being mutual aid to other agencies. Approximately 67.5 man hours were expended.

Mr. Gibson reported that the fire department members voted unanimously on Monday night to apply for 501(c) 3 status. He will contact Kimberly Jackson, CPA for assistance with the budget and application forms. Mr. Pecht reported that he does not anticipate any change in the level of support that the Town provides to the department. The designation will help the fire department obtain grants for trucks and equipment. Mr. Brockwell commented that a ladder truck needs to be replaced to maintain the insurance rating.

PERSONNEL

Mr. Brockwell commented that the committee has been very busy with town manager applications and there is a need for a closed session tonight. No applications have been received for the Chief Water Plant Operator. All open positions continue to be advertised. C. J. Dean is still assisting with reporting requirements.

POLICE

Ms. Hardy advised that the report is in the packet.

PROPERTY & EQUIPMENT

Mr. Brockwell advised that the Brick and Tile property acquired by the Town includes a site on Cattail Drive that was once a Dairy Hut. A business owner is interested in the property. The Town would have to declare it surplus and transfer ownership to the LEDA before the property could be sold. This is for information only and no action is requested at this time.

Mr. Brockwell reported on meeting with Mr. Lynch and learning about a GIS system that he is using to locate town property, lines and hydrants.

STREETS, LIGHTS & CEMETERY

Mayor Martin commented that public works is doing all they can with the help they have. Grass that has been sprayed and died needs to be cleaned up.

TOWN DEVELOPMENT

Mr. Brockwell reported that the public works department is short three people and there is one planning to retire in January.

WATER/WASTEWATER

There will be a committee meeting following the regular meeting tonight.

SAFETY

Mr. Brockwell reported that the information is in the packet. Also, Mr. Gibson has been in numerous meetings learning about training needed for COVID. This will take quite a bit of in service training in the near future.

HOUSING CODE ENFORCEMENT

Mayor Martin reported that this has been on the backburner during the pandemic. Property concerns and tall grass need to be addressed.

PARKS/RECREATION

Mrs. Talbert asked if there has been a report on the LOVE sign project. Mr. Gilson will be contacted about this. Mr. Brockwell reported that there will be a fall league at the ballpark. The sign up day is Saturday.

WELLNESS

Ms. Whitehead provided a list of suggestions for COVID-19 supplies. She also showed a packet that she had received from VCU that contained 3 masks, disinfectant and sanitizer that VCU provided to its employees.

FARMER'S MARKET

Mayor Martin commented that the market did not work out with the conditions this year. We will meet with the new owners of the market site for next year.

LAWRENCEVILLE PLANNING COMMISSION

Timothy Puryear has been advised of his appointment to the commission.
