ZONING AMENDMENT DRAFT

Cindy Pecht, Planning Commission Chair, presented a proposed zoning amendment to Article 6. B-G Business General District, 6-1-32. This would allow for rental of residential space with at least one floor of finished space below the residential floor. The amendment would align with the historic overlay and the comprehensive plan. All residential uses are subject to requirements in the Rental Inspection District, the Virginia State Building Code and the Fire Code. The Planning Commission recommends that a joint public hearing of the Planning Commission and Town Council be held to hear public comments on the proposed amendment.

LAWRENCEVILLE EDA

Mr. Gilson reported that the EDA has not been able to meet. Earlier today Mr. Gilson sent out a picture of the base and frame for the LOVE sign. The next step is for the town crew to lay down the track.

MAYOR'S REPORT

Mayor Martin thanked Mr. Outten, Mr. Gibson and Council for all the items we have been working on. We have been very proactive. The office has been sanitized. He thanked the ladies in the office, the police and all the departments and asked that everyone stay safe and stay healthy. Mayor Martin, Mr. Brockwell. Mr. Gibson and Wendy Wright have been working on the Cost Share Grant Application for the Historic District. POPS is coming together nicely. Mr. Gibson will address other conference calls and WebEx meetings. We are getting a lot done considering the pandemic that we are dealing with.

REPORT OF TOWN ATTORNEY

Mr. Outten advised that there is a letter in the packet regarding KASS. Mr. Gibson will report on it as he has been in touch with the Southside Planning District regarding this project.

REPORT OF TOWN MANAGER

OLD SOUTHERN STATES BUILDING - KASS

Mr. Gibson reported that all of the entities involved are working together on the KASS project.

CURRENT SIDEWALK PROJECTS

North Main Street Sidewalk – Mr. Gibson reported that the Main Street project is almost complete and looks great. We are waiting for the light poles to be set. They have not come in yet. Heritage Trail/Gazebo Sidewalk – There will be a Zoom meeting tomorrow on this project. The bids should go out soon.

ST. PAUL'S COLLEGE CAMPUS RE-USE PROJECT

Mr. Gibson advised there is a report from Sanford Holshouser on potential re-uses for the St. Paul's College Campus. He participated in a Zoom meeting on this project. It is an overview concept report of areas for re-use, studies of buildings and historic background information. Brunswick County has asked for the Town's support of the re-use report. This is only for a letter of support, not for any monetary commitment from the Town. On motion by Mr. Brockwell, seconded by Mr. Pecht and carried, Town Council voted to accept the report and write a letter of support for the St. Paul's Re-Use Study. Motion: Mr. Brockwell. COST SHARE GRANT APPLICATION – HISTORIC DISTRICT

Mr. Gibson asked for permission from Town Council to sign and submit a Survey and Planning Cost Share Grant Application to the Virginia Department of Historic Resources. The project would update the Historic District, survey the existing buildings and include approximately 63 buildings as contributing resources with a period of significance extended to 1970. FINANCE COMMITTEE

TENTATIVE ADOPTION OF THE FY2020-2021 BUDGET

BENCHMARK LOAN PROPOSAL

Mr. Pecht reviewed the loan proposal from Benchmark Community Bank. Proposal #1 would be a \$300,000 term loan at 3.79% interest to purchase vehicles. Proposal #2 would provide funds for a term of 20 years for long term infrastructure projects. Mr. Pecht recommended that council hold this until the June meeting for final approval.

FIRE AND EMERGENCY SERVICES

The March report is in the packet. The fire department responded to 32 calls in March. Of the 32, 7 were in the town limits and 25 were outside the town limits. Also, 22 were in the LVFD First Due area, with 10 being mutual aid to other agencies. Approximately 191 man hours were expended. Members of the fire department will be going to look at a used ladder truck this weekend. They will address that with the fire committee.

Mr. Brockwell asked Mr. Gibson to continue work on the organizational flow chart and a review of the evaluation process.

POLICE

Ms. Hardy advised that the report is in the packet. She asked that everyone stay safe and wear a mask.

There is a tree down in the cemetery. We will work with our current contractor to provide more mulch and trimming to the circle. We will take care of the tree as well.
