The reissuance of the Lawrenceville WWTP Permit has been approved to advertise for public notice. Public notice will start, Wednesday, July 23, 2025 and will continue for 30 days for public comment. Pending public response and satisfying all public comments, the permit will be executed. DEQ can address comments.

#### TTHM & HAA5 UPDATE

The Town has completed out second quarterly testing for the TTHM and HAA5, and the results were favorable and reflects a significant decrease from the second quarter of 2024.
