1. Storage Conditions: The assigned storage space is outdoors and subject to weather and natural events.

Morning Dove Storage is not responsible for any damage caused by wind, rain, snow, storms, animals, ground movement, or any other act of nature.

2. Liability & Insurance: The boat owner agrees to hold Morning Dove Storage harmless for any damage, loss, theft, or vandalism occurring during the storage period. By signing this Agreement, the owner affirms they have an active insurance policy covering the stored vessel.

3. Winterization Requirements: Before storage, the boat must be winterized. The boat owner must provide a completed Winterizing Certification Form signed by a certified marine mechanic or marina.

4. Shrink Wrapping & Preparation: The boat must be delivered to Morning Dove Storage fully sealed with shrink wrap to prevent water intrusion, protect structural components, and manage environmental runoff. Delivery shall occur on a scheduled date agreed upon by both parties.

5. Retrieval After May 31st: Boats retrieved after May 31, 2027 will incur an additional fee of \$10.00 per day unless arrangement made with owner for summer storage. There is no proration for late arrival or early removal.
