# Empowering Futures First Aid Policy (Including Processes & Code of Conduct)

#### **Legislation**

The Health and Safety at Work Act 1974
The Health and Safety (First-Aid) Regulations 1981

#### **Definitions**

First aid is defined as:

- Providing help for the purpose of preserving life and minimising the consequences of injury or illness until such time as professional medical support can be obtained; and
- Treating minor injuries which would not otherwise receive any treatment or which do not warrant treatment by a medical professional (Doctor, nurse, paramedic).

#### **Policy Statement**

- The Health, Safety and Environment Service has delegated responsibility to ensure that adequate arrangements are put in place to provide sufficient first aid provision. It will do this via a First Aid Needs Assessment.
- Although there is no requirement in law to provide first aid to anyone other than employees, Empowering Futures will make provision for the benefit of its participants and visitors.
- In recognition of this Empowering Futures provides additional resource in high risk areas. We have a comprehensive Risk Assessment for the farm / site

#### First Aid Embedding Processes

Empowering Futures has an Appointed Person who is responsible for our First Aid arrangements, including:

- a) compiling a First Aid Needs Assessment;
- b) ensuring we have adequately trained personnel on-site and that there training is up-to-date and at an appropriate level;
- c) maintaining and keeping stocked the First Aid equipment and facilities;
- d) displaying a list of First Aid personnel in a prominent place;
- e) calling the Emergency Services when required.

#### **During the induction process:**

- i) all staff and volunteers will be shown the location of the First Aid kit; which will be in an appropriate place and clearly signposted;
- ii) the location of the accident forms and the log file is in the top drawer of the Hub Admin filing cabinet.
- iii) The First Aider Role & First Aider Code Of Conduct (Appendix 1 below)

# First Aider Code Of Conduct

#### The role of the First Aider is to

- 1. Preserve Life
- 2. Prevent situation worsening assess situation, remove further danger, get help
- 3. Promote recovery prioritise treatment, minimise infection, get bystanders to help

#### Use Head and NOT Heart

#### By using the DRABC survey

- 1. Danger is there further danger for casualty, bystanders keep safe
- 2. Response assess consciousness
- 3. Airway is it clear, turn onto back, listen for ten seconds
- 4. Breathing clear blocked airways, tilt head to clear,
- 5. Circulation chest compressions 30/2 rescue breaths

If Unconscious - recovery position stops airway from being blocked, or choking

#### **Assess Levels of response**

Alert Voice Pain

Unresponsive

#### **Choking**

Are you ok?
Encourage to cough
Back blows
Abdominal thrusts

**Blood loss** - pressure/bandage/avoid objects embedded by packing out

Arterial- spurts
Venous -may ooze
Capillary - more of a trickle

**Shock** - keep warm, raise legs, loosen clothing

- 1. Pale clammy skin
- 2. Dizziness
- 3. Fast weak pulse
- 4. Rapid shallow breathing

- 1. Scrape off with credit card
- 2. Elevate injury
- 3. In mouth ice cube if possible

#### Nose bleed

1. Sit down / tilt head forwards

#### **Amputation -call 999**

- 1. Dress with non fluffy dressing
- 2. Place amputation in bag / keep dry/cold

#### Penetrating injury - call 999

1. Apply pressure to bleed

#### Eye injury- call 999 or take to hospital

- 1. Sterile eye dressing over eye
- 2. Close good eye
- 3. Chemicals in eyes irrigate with clean water

#### **Burns**

- 1. Under water for minimum of ten minutes
- 2. Remove jewellery / loosen clothing
- 3. Cling film not tight
- 4. Bag

#### Never

Touch the burn
Burst blisters
Apply ice
Apply creams
Adhesive dressings
Remove anything stuck to burn

#### **Broken Bones - call 999**

- 1. Look for swelling
- 2. Loss of power
- 3. Bruising
- 4. Lumps /depressions
- 5. Sound of bones grating
- 6. Tenderness
- 7. Keep warm
- 8. Immobilise injury
- 9. Suspected spinal injury do not move, hold head still, reassure
- 10. If unconscious hold head still

#### **Diabetes**

- 1. Low sugar signs -strange behaviour, can be mistaken for drunkeness, pale, cold clammy, shallow rapid breathing, fast pulse, may have insulin pen, administer sugary drink
- 2. If unconscious place in recovery position, keep airways clear
- 3. Call 999

#### Heart attack - call 999

Pressure in chest / severe sweating / shortness of breath May spread to arms / neck / jaw - dizziness Pale, cold clammy skin, sometimes blue/grey lips Sit them down If angina sufferer - administer angina medication Reassure Give aspirin if over 16 yrs

#### **Stroke**

FAST test Facial weakness Arm weakness Speech problems

#### Time to call 999

Other signs - loss of balance/coordination/severe headache/confusion Unconscious casualty - Lay down - recovery position Conscious - lay down with head and shoulders raised

#### **Asthma**

Wheezy breath
Difficulty breathing / speaking
May become unconscious

- 1. Help casualty sit upright
- 2. Use inhaler
- 3. Reassure
- 4. Keep indoors
- 5. Keep upright
- 6. Call 999 if unconscious or cannot get breathing controlled

#### <u>Anaphylaxis</u>

<u>Signs - blotchy skin</u>
Rapid onset of breathing/circulation/airway problems
Call 999
Lay down

If auto injector of insulin on them, should be able to self administer, if not, assist
