# LAKE UPDATE



Several residents have expressed concern that the second box unit and location is an eyesore. We are also looking to possibly move that box across Whippoorwill Drive away from the Stop Sign. This new box is tentatively scheduled to be installed this weekend (April 6th or 7th).
