NEW BOARD MEMBER

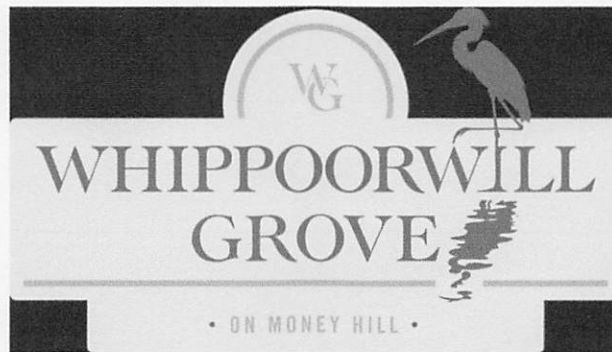
