

ORDER

WHEREAS, there has historically been demand for team and individual photography that relate to the activities in the Hemphill Park; and

WHEREAS, it now appears that more than one vendor may wish to come upon City property and solicit photography and business and related business;

NOW THEREFORE, the City of Florence, in order to regulate and monitor such activity does hereby order that photography vendors can solicit photography business with regard to the activities in the Hemphill Park upon the following terms:

1. Complete an application and tender a permit fee in the amount of \$ 350.00, consistent with the application which is attached hereto and hereby herein incorporated as Exhibit "A";
2. Provide to every potential patron the physical address of the photography vendor, the mailing address of the photography vendor, the telephone number of the photography vendor;
3. The photography vendor, if an individual or group of individuals, must give the name and address of each individual that is a principal in the business. If the photography vendor is a Corporation or Limited Liability Company, the photography vendor is to set out the name,

address, and phone number of the business and a principal with a majority interest in the business;

4. In the event that a photography vendor receives a complaint, within fourteen (14) days of receipt of the complaint the photography vendor shall notify in writing the Director of Parks of the problem and what, if anything, was done to resolve it. In such event, if, in the discretion of the Park Director, there is interest in receiving additional information about the issue, same shall be timely provided;
5. If complaints are not resolved to the satisfaction of the Director of Parks, then the permit to be a photography vendor in the Hemphill Park will be suspended or revoked with no refund of application fee.
