

CITY OF FLORENCE  
REGULAR MEETING OF MAYOR AND BOARD  
DECEMBER 2, 2025

The Governing Authorities of the city of Florence met in their regularly scheduled meeting set for the 1<sup>st</sup> Tuesday in December, December 2, 2025 at 6:30 p.m. at city hall located at 203 College Street in Florence, Mississippi.

Initially present were Mayor Pro Tem Grantham, Aldermen Banks, Herrin, Martin and Sistrunk. Mayor Gunn was absent.

Mayor Pro-Tem Grantham called the Meeting to order and announced a quorum.

Alderman Sistrunk gave the invocation.

Upon recommendation of Public Works Water/Sewer Operator, Billy Russell, a Motion was made by Alderman Banks, seconded by Alderman Herrin to approve the quote of Woolwine Ford Lincoln, Inc. in the amount of \$60,680.00 for the purchase of a 2026 Ford F350 SRW Crew Cab 4X4 pick-up truck, the lowest and best quote of two received as follows, contingent upon verifying 2026 year of vehicle.

The Motion was carried by a unanimous vote.

Upon recommendation of Public Works Water/Sewer Operator, Billy Russell, a Motion was made by Alderman Banks, seconded by Alderman Sistrunk to approve the quote of Aquatic Informatics in the amount of \$9,523.48 for the purchase of annual a Water Data Management Software Program for the Public Works Department, a sole source provider, letter attached. The Motion was carried by a unanimous vote.

Upon recommendation of Public Works Water/Sewer Operator, Billy Russell a Motion was made by Alderman Banks, seconded by Alderman Sistrunk to authorize and direct City Engineer Tim Parker to assess the sewer system in Stonebrook Subdivision and report his findings to the board. The Motion was carried by a unanimous vote.

Alderman Mason Herrin left the meeting.

Upon recommendation of City Engineer, Tim Parker, a Motion was made by Alderman Sistrunk, seconded by Alderman Martin to approve **CONTRACT CHANGE ORDER NO. 2 FROM THORNTON CONSTRUCTION, INC. IN THE AMOUNT OF \$7,500.00 FOR ADDITION OF LINE-ITEM CO2.0 "MODIFICATION OF PUMP IMPELLARS" ON THE MCWI #255-2-CW-5.5 HWY 49 EAGLE POST ROAD SANITARY SEWER ADDITIONS-PHASE 3 PROJECT.** The Motion was carried by a unanimous vote.

Alderman Mason Herrin returned to the meeting, having not participated nor deliberated in no wise for the city.

A Motion was made by Alderman Herrin, seconded by Alderman Banks to **ADOPT A BOARD ORDER CONCERNING OBSERVANCE OF THE CHRISTMAS AND NEW YEAR HOLIDAYS.** The Motion was carried by a unanimous vote.


