#### **SHOW RULES**

- 1. All entries are subject to the General Rules & Regulations of Canadian Western Agribition. Please refer to these rules and read them carefully.
- Completed online entry form and payment of fees must be received by October 1.
- 3. Entry Fees: Single Entries: \$40.00/entry. GST payable on all fees. "Show Only" Fees \$40.00/head for Purebred animals not entered in the Sale. Refer to Sale Exemption Rules #2 for fee exemptions. The "Show Only" Fee will be administered by the SSBA and will be collected immediately following the completion of vet checks.
- 4. Substitution Fees: \$20.00/animal, plus GST. All substitutions must be made by 2:00 PM, Thursday, December 1 at the Livestock Entries office.
- 5. As of January 1, 2004, all sheep and lambs must bare an approved CSIP ear tag before they leave the farm of origin and any subsequent premises.
- 6. Sheep must be in pens by 12 pm Thursday, December 1. Animals are released at 6 pm Saturday, December 3 and must be out of the barn by 8 am Sunday, December 4.
- 7. All sheep will be inspected by a Veterinary Check Committee for health, tags, tattoos, papers, etc. All consignors must be present with their sheep for the inspection. Approximately 1:00pm-4:00pm Thursday, December 1. All blankets must be removed and sheep must be dry. In addition to any conditions that could compromise the health and soundness of the animal or any other animal in the barn, they must have proper RFID tags or legible tattoos for purebred, registered animals. Original certificate of registration papers must be presented to the Inspection Committee. All animals born in 2015 and later must be presented according to the National Farm Animal Care Council Code of Practice for the Care and Handling of Sheep. All animals showing signs of unhealthiness or not meeting code of practice standards will be removed from the show & sale, and must be removed from the barn immediately. There is no holding area in the barn for culls or in- transit animals. The ram's tail length must be no shorter than the distal end of the caudal-fold. The ewe's tail length must be no shorter than the distal end of the caudal-fold and completely covering the vulva.
- 8. Sheep will be mouthed to be eligible to show as follows:
  - a. Lambs: First pair of temporary incisors must still be in place.



- b. Yearlings: Third pair of temporary incisors must still be in place.
- 9. Exhibitors are required to wear white shirt and black pants when showing. Failure to comply with this rule will result in exhibitor being disallowed to show or be banned the following year; up to show management.
- 10. Penning will be assigned; tack stalls may have to be shared. For more information, please contact the SSBA Barn Boss.
- 11. Show order will be determined and posted as soon as possible. Subject to changes.

#### SSBA PUREBRED SHOW RULES

- 1. All sheep must be purebred and registered with CLRC or their official Canadian breed registry, and must be properly tattooed or have appropriate ID tags in ears that match registration paper.
- 2. In order to have a Breed Show, there must be a minimum of 3 exhibitors and 10 animals in each section. Management reserves the right to combine sections into an "Any Other Breed" classification.
- 3. Purebred class entries must be owned by and registered in the name of the exhibitor.

#### **CLASS**

- 1. Mature Ewe, two years old or older.
- 2. Ewe with current year lamb at side, born January 1, 2022 or later.
- 3. Yearling Ewe.
- 4. Fall Born Ewe Lamb, born August 1, 2021 November 27, 2021.
- 5. Ewe Lamb, born November 28, 2021 last day of February 2022.
- 6. Ewe Lamb, born March 1, 2022 and later.
- 7. Grand Champion Ewe and Reserve Grand Champion Ewe.
- 8. Mature Ram, two years old or older.
- Yearling Ram.
- 10. Fall Born Ram Lamb, born August 1, 2021 November 27, 2021.
- 11. Ram Lamb, born November 28, 2021 last day of February 2022.
- 12. Ram Lamb, born March 1, 2022 and later.
- 13. Grand Champion Ram and Reserve Grand Champion Ram.
- 14. Get-of-Sire: A group of three animals by the same sire, born the property of the exhibitor. First pair of temporary incisors must still be in place. Both sexes represented. These must be lambs. Animals must have been exhibited in previous classes. No entry fee, but entry must be made.
- 15. Breeder's Flock: A group of four animals bred and owned by the exhibitor. Both sexes represented. Each animal in the group must have been exhibited in one of the preceding classes. All animals in a group to be of one breed. No entry fee, but entry must be made.
- 16. Premier Breeder: No entry needed. Sheep must be exhibited at the show by the breeder to be eligible for Premier Breeder points.
  - Points:  $1^{st} 7$ ,  $2^{nd} 6$ ,  $3^{rd} 5$ ,  $4^{th} 4$ ,  $5^{th} 3$ ,  $6^{th} 2$ ,  $7^{th} 1$ .
- 17. Rookie of the Year: No entry has to be made but must be a first-time exhibitor. Points are to be awarded the same as the Premier Breeder scoring system. Exhibitor must be current owner and breeder of animals shown.
- 18. Premier Exhibitor: No entry to be made. Points calculated same as Premier Breeder. Exhibitor must be current owner.



- 19. Best Pair of Purebred Ewes: No entry has to be made but must notify the show committee you are entering upon arrival. Ewes can be any combination of breeds or ages but must have been shown in a previous class. One entry per exhibitor. Class will commence immediately prior to Supreme Show.
- 20. Supreme Champion Ewe, Ram, and Breeder's Flock: Entries from Grand Champion Sections. Banner presented by Canadian Western Agribition.
- 21. Interprovincial Champion: No Entry to be made. Groups of four head from the purebred classes. Both sexes represented. Two groups from each province to qualify (groups to be selected by the breeders participating). Each group shall be of one breed.

# COMMERCIAL & PUREBRED PEN SHOWS & SINGLE COMMERCIAL EWES – SECTION 300P COMMERCIAL EWES AND PEN SHOW RULES

- 1. Open to any straight-bred or crossbred ewes.
- 2. Ewes in this section may not be shown in any other classes.
- 3. All entries in this section will sell in the sale. See Sale Rules.
- 4. Pen classes may show in pens with halter or in show ring (final decision made by show management).
- 5. 1st and 2nd placements in pen class will show in Classes 15 or 19.
- 6. Classes 15 and 19 will show on halter in the ring.

#### **CLASS**

- 1. Single Commercial Ewe Lamb, born November 28, 2021 last day of February 2022.
- 2. Single Commercial Ewe Lamb, born March 1, 2022 and later.
- 3. Single Commercial Yearling Ewe.
- 4. Mature Ewe, two years old and older.
- 5. Ewe with current year lamb at side, born January 1, 2022 and later.
- 6. Grand Champion and Reserve Grand Champion Single Commercial Ewe.
- 7. Pen of Five Commercial Ewe Lambs, born November 28, 2021 last day of February 2022.
- 8. Pen of Five Commercial Ewe Lambs, born March 1, 2022 and later.
- 9. Pen of Three Commercial Ewe Lambs, born November 28, 2021 last day of February 2022.
- 10. Pen of Three Commercial Ewe Lambs, born March 1, 2022 and later.
- 11. Pen of Two Commercial Ewe Lambs, born November 28, 2021 last day of February 2022.
- 12. Pen of Two Commercial Ewe Lambs, born March 1, 2022 and later.
- 13. Pen of Two Commercial Yearling Ewes.
- 14. Pen of Two Commercial Ewes, two years old or older.
- 15. Grand Champion and Reserve Grand Champion Pen of Ewes.
- 16. Pen of Three Purebred Ewe Lambs (all breeds), born November 28, 2021 last day of February 2022.
- 17. Pen of Three Purebred Ewe Lambs (all breeds), born March 1, 2022 and later.
- 18. Pen of Two Purebred Yearling Ewes (all breeds).
- 19. Grand Champion and Reserve Grand Champion Pen of Purebred Ewes.



#### MARKET LAMBS – SECTION 300M

#### MARKET LAMB SHOW RULES

- 1. Lambs in this section may not be shown in any other classes.
- 2. Weighing of market lambs will take place Thursday, December 1 by the Barn Boss. All lambs must be dry at weighing and must remain in their allotted stalls after weighing.
- 3. Weight restrictions for market lambs 90-120lbs.
- 4. All entries in this section will sell in the sale. See Sale Rules.

#### **CLASS**

- 1. Wether or Ewe Lamb: 90 120 lbs.
- 2. Grand Champion and Reserve Grand Champion Market Lamb.

### **JUNIOR SHOW – SECTION 300J**

#### **SHOW RULES**

- 1. No CWA entry fee. Entry must be made online by October 1 with regular sheep show entries.
- 2. Showmanship entries may be made to Show Management prior to Showmanship class start time. Splits will be made in line with 4-H age ranges.
- 3. Animals entered in the Junior classes are not required to be sold, **EXCEPT** if the animal is entered in an open class. Refer to Sale Exemption Rules
- 4. Open to boys and girls 21 years old and younger.
- 5. Ewes of any breed or breed cross eligible to compete.
- 6. Health requirements for sheep apply as listed in Show Regulations.

#### **CLASS**

- Ewe Lamb
- 2. Yearling Ewe
- 3. Mature Ewe, two years old or older.
- 4. Showmanship: No entry fee, but entry must be made online, to the Saskatchewan Sheep Breeders Association, or Show Management prior to the class starting. Entrants need not own the animal.
- 5. Junior Costume Class: 11:00 AM, Saturday, December 3 Entrants need not own the animal they are showing (19 years and under).
- 6. Adult Costume Class: In conjunction with Junior Costume Class. Entrants need not own the animal they are showing (any age).



#### SHEEP SALE RULES

- 1. Sale: 1:00 PM Saturday, December 3.
- 2. Sale entries are identified during online registration.
- 3. Auctioneer: Scott Johnstone, Johnstone Auction Mart, Moose Jaw, SK.
- 4. All Purebred Rams and Ewes must be registered with CLRC, their official Canadian breed registry, or their national registry if no Canadian registry exists to be eligible to show and sell as such.
- 5. Registration papers and signed transfers for registered sheep must be presented upon arrival at Agribition to the SSBA. If papers are not provided, animal will not sell.
- 6. Sale Commission: 7% to Saskatchewan Sheep Breeder's Association; 3% to Canadian Western Agribition. There is no maximum commission.
- 7. Guarantee: Ewes and rams entered in SSBA sales are guaranteed by the consignor as breeders. The consignor will stand behind their animals, and if any problems arise, they are to be handled directly between the seller and purchaser.
- 8. Sale order will be determined and posted as soon as possible. Will be subject to changes.

#### **Sale Exemption Rules:**

- 1. Animals that are entered in Section 300J ONLY may be exempt from sale.
- 2. Purebred Exhibitors selling at least 2 animals are exempt from "Show Only" fees for all animals.
