



# BROKER-CARRIER TRANSPORTATION AGREEMENT

### 1. RELATIONSHIP OF PARTIES

Broker is a licensed property broker (49 U.S.C. §13102). Carrier is an authorized motor carrier. Carrier is an independent contractor; nothing herein creates an employment relationship.

### 2. CARRIER QUALIFICATIONS

Carrier warrants it: (a) holds active FMCSA authority; (b) maintains required insurance; (c) employs only qualified, licensed drivers; (d) complies with all applicable regulations.

### 3. RATES & CHARGES

Compensation set forth on applicable Rate Confirmation. No additional charges without prior written authorization. Carrier shall invoice Broker within 30 days of delivery with signed POD.

### 4. CARGO LIABILITY

Carrier accepts cargo liability under 49 U.S.C. §14706 (Carmack Amendment). Minimum cargo insurance: \$100,000. Claims filed in writing within 9 months of delivery.

### 5. INSURANCE REQUIREMENTS

Carrier shall maintain: (a) Auto Liability: \$1,000,000; (b) Cargo: \$100,000; (c) General Liability: \$1,000,000. Broker named as additional insured on auto liability.

### 6. NO RE-BROKERING

Carrier shall not re-broker, subcontract, or interline any shipment without prior written consent. Violation entitles Broker to withhold payment and seek damages.

### 7. PAYMENT TERMS

Payment within 30 days of complete shipping documents (invoice + signed POD). Quick Pay available at agreed discount rate on Rate Confirmation.

### 8. INDEMNIFICATION

Each party shall defend, indemnify, and hold harmless the other from claims arising from its own negligence, misconduct, or breach of this Agreement.

### 9. TERM & TERMINATION

Effective upon execution. Either party may terminate upon 30 days written notice. Existing obligations survive termination.

### 10. GOVERNING LAW



Governed by the laws of the State of Missouri and applicable federal transportation law.
