Each year the Central Texas Crime Prevention Association (CTCPA) recognizes members of the association as well as others who have made a significant impact in the field of Crime Prevention. Although everyone is deserving of an award for all the hard work and activities you do, it's not quite that easy. Please take time to reflect over the past year and if you have someone you would like to nominate for an award please complete the enclosed form no later than 11:59 pm (CST) on November 10th, 2024. Below is a list of our 2024 award categories:

**CTCPA AWARDS CATEGORIES:**

**1. OUTSTANDING CITIZEN CRIME PREVENTION AWARD:**

An award will be presented to a volunteer or to a citizen whose dedication to the crime prevention effort has earned special recognition. The recipient of this award cannot be an employee, sworn or non-sworn, of a law enforcement agency.

**2. OUTSTANDING CORPORATE / BUSINESS AWARD:**

An award will be presented to the business that has made the greatest impact or provided the greatest support toward the crime prevention effort.

**3. OUTSTANDING MEDIA AWARD:**

An award will be presented to the media – print and/or electronic – whose management and staff have been most supportive of the goals and objectives of a crime prevention activity or activities.

**4. OUTSTANDING CRIME PREVENTION PROGRAM:**

An award will be presented to the agency for the Crime Prevention Program making the greatest overall contributions to Crime Prevention in the Central Texas Region.

**5. WILLIE TISDALE AWARD (HORIZON AWARD):**

An award will be presented to a Crime Prevention Practitioner making the greatest contributions to crime prevention and who has been newly assigned for less than two years to crime prevention. The recipient must be a CTCPA member in good standing.

**6. MCGRUFF/ PUBLIC SAFETY MASCOT AWARD:**

An award will be presented to the individual making the greatest contributions to crime prevention while working with McGruff or other Public Safety Mascot and keeping with the McGruff/Public Safety Mascots traditions.

**7. OUTSTANDING CRIME PREVENTION AGENCY:**

- a) Small Agency – up to 99,999
- b) Medium Agency – 100,000 to 249,999
- c) Large Agency – 250,000 +
- d) Specialized Agency -

\*Note (by population the agency serves, not the size of the agency itself).

An award will be presented in each category to the agency that has made the most substantial contribution(s) to the field of crime prevention and to the CTCPA. An Agency is defined as a unified body of professional law enforcement personnel, not necessarily sworn officers, whose object is the prevention, control, and/or elimination of crime. The agency must have at least one CTCPA member in good standing.

**8. OUTSTANDING CRIME PREVENTION MANAGER:**

- a) Small Agency – up to 99,999
- b) Medium Agency – 100,000 to 249,999
- c) Large Agency – 250,000 +
- d) Specialized Agency

An award will be presented to an administrator or crime prevention program director demonstrating the greatest support and leadership for personnel in crime prevention and has at least one CTCPA member in good standing.

**9. OUTSTANDING CRIME PREVENTION SPECIALIST:**

- a) Small Agency – up to 99,999
- b) Medium Agency – 100,000 to 249,999
- c) Large Agency – 250,000 +
- d) Specialized Agency

\*Note (by population the agency serves, not the size of the agency itself).

An award will be presented in each category to the specialists who have made the greatest contribution(s) to crime prevention. The recipient must be a CTCPA member in good standing.

**10. OUTSTANDING CRIME PREVENTION SPECIALIST – OVERALL:**

An award will be presented to the individual making the greatest *overall* contributions to crime prevention. The recipient must be a CTCPA member in good standing.

**11. ABOVE AND BEYOND AWARD:**

- a) Small Agency – up to 99,999
- b) Medium Agency – 100,000 to 249,999
- c) Large Agency – 250,000 +
- d) Specialized Agency

\*Note (by population the agency serves, not the size of the agency itself).

An award may be presented in each category to the individual who has gone above and beyond to make a significant contribution or notorious service or merit requiring valor, honor, and heroism was beyond the normal call of duty. The recipient must be a CTCPA member in good standing.

**NOMINATION CRITERIA:**

1. Nominations are for activities during the period of November 1, 2023 through October 31, 2024
2. Entries must be summarized in accordance with the official nomination form provided or format should be in accordance with the nomination form.
3. The form may be locally reproduced.
4. Each nomination must be complete.
5. The nominator must be a CTCPA member in good standing.
6. Each nomination must be endorsed by the nominee's Sheriff, Constable, Chief of Police or immediate supervisor if nominee is from a state or federal agency or from private industry.
7. Nominees may be nominated in more than one category. A separate form must be completed for each nomination.
8. Nominees will receive notification of their status as nominees.
9. All nominations must be postmarked or emailed or no later than 11:59 pm (CST) on November 10, 2024 No material may be submitted after this date. All material will become the property of the CTCPA and not returned.
10. Nominations must be sent to the CTCPA Awards Committee Chairperson via postal mail or email.
