### 2026 Resident Home Painting Plan / Process

### **Greetings DEVONSHIRE HOMEOWNERS**

We are excited to confirm that in January 2026 our homes are scheduled to be painted.

Please take a few minutes to review the following important information...

- ATTACHED is the most current master list of each resident's home exterior colors (Sherwin Williams / SW Paint codes) listed by address.
- The first step in pre-planning with our painting contractor and DEVONSHIRE Board Director, JO
   GAMELLI (who has graciously volunteered to lead and coordinate this community effort) will be to
   schedule a drive around for the contractor to "confirm" (to the best of his abilities the existing home
   color combinations for each residence MATCHES what is listed on the current master paint code list.
   We can't "assume" the attached master list is 100% accurate.
- Any changes they see (example: a different door color from what is listed) will be noted...but it will
  ultimately be the "resident's responsibility" to complete and submit a COLOR PAINT CODE FORM no
  later than Nov 30, 2025 confirming the correct paint codes for your home. Failure to submit a fully
  completed / executed COLOR PAINT CODE FORM will result in your home being painted the color
  combination currently listed.
- You can easily confirm the current color of your home by going to the clubhouse office and requesting to view the approved paint code catalog notebooks (volume 1 and 2) where all "approved" SHERWIN WILLIAMS (SW) home color combinations (swatches) are available for review (look up your "KR" number noted for your address on the list. All paint codes used last time...you'll find in volume 1. Newly approved paint codes (Volume 2) were added after the last painting in July 2021.
- You can also go ON-LINE to view both volumes of KINGS RIDGE APPROVED PAINT COLOR COMBINATIONS. Direct links are provided below or simply search...Sherwin Williams HOA...choose Florida...then Clermont...then Kings Ridge.

- FLORIDA PAINT® will be used...this premium quality paint is engineered and manufactured in FLORIDA to be mold and mildew resistant as well as withstand the harsh weather conditions of the Florida sun and intense heat. FLORIDA PAINT's warranty mirrors the SHERWIN WILLIAMS paint warranty of 6 years on the house and soffit paint. FLORIDA PAINT will "COMPUTER COLOR MATCH" all colors to existing SW codes.
- EVERY HOMEOWNER will be required to sign the attached COLOR PAINT CODE FORM confirming (1) they plan to maintain their existing color listed...or...(2) go with 1 of 2 additional options...

- OPTION 1: COLOR OF THE HOME...there is a charge of \$500. Your check must be attached to
  the fully executed COLOR PAINT CODE FORM due no later than Nov 30, 2025. Make your check
  payable to ERNESTO LEONARD and simply postdate it to January 1, 2026.
  - o IMPORTANT...NO TWO HOUSES "SIDE BY SIDE" can have the same color combination.
- OPTION 2: CHANGE COLOR OF FRONT DOOR / GARAGE DOOR...there is a charge of \$200...payment requirements are the same as detailed in OPTION 1.
  - Doors may be painted either of the 2 approved "door" colors for the KR code, either trim color for the KR code, or 1 of the 6 "newly" approved door colors.
- IMPORTANT: Again, the attached COLOR PAINT CODE FORM must be fully executed and signed by
  the homeowner regardless of whether you are planning to change your house color combination or
  not. Failure to of the homeowner to submit the required signed / executed COLOR PAINT CODE
  FORM (along with any applicable payment...if changing from your existing color combination) by the
  stated deadline of Nov 30, 2025, will result in your home being painted the colors listed on the
  master paint code list for your address.
- There will be "NO REDOS" unless the painting contractor makes a mistake.

Again, your **DEVONSHIRE** "KEY POINT OF CONTACT" will be DEVONSHIRE BOARD DIRECTOR: Joanne (Jo) Gamelli / 407-460-2188.

Please turn in your fully executed signed COLOR PAINT CODE FORM to Jo no later than NOV 30, 2025.

#### **PAINTING PROCESS:**

- Homeowners are responsible for removing all items from their front porch and back lanai areas.
- Homes will be painted in blocks of 10...typically beginning on a Monday...the painting process steps include...
  - o Complete Pressure Washing of the exterior surface areas to be painted.
  - o Cover all cracks on walls with concrete grade texture to match existing.
  - Apply caulking to all windows and trim.
  - o Cover all windows, floors, plants, and sidewalks to prevent overspray.
  - Apply one coat of LOXON conditioner sealer to all surfaces to be painted.
  - Apply (spray and back roll) one coat of FLORIDA PREMIUM PAINT to all stucco, trim, and front doors.
- PAINTING of each block of 10 homes should be completed by THURSDAY or FRIDAY of the same
  week painting commenced...the paint contractor and "Jo G" will be work together to inspect each
  home and note any visible corrections needed. It's advised...that YOU...as the homeowner be part of
  this required inspection.
- Once a block of 10 homes are deemed fully painted and there are no issues to be addressed...the
  process moves on to the next block of 10 homes...this process is repeated until all 90 Devonshire
  homes have been painted.

Be looking for additional communications as the date for painting our homes draws near (i.e. providing a schedule of the sequence for which block of homes will be painted and when).
