5. **COMMITTEES:**

- Landscaping (Mr. Leaberry): The Down to Earth crew is in attendance to provide a community update and answer any resident questions/concerns. The crew is mowing each week. The updated zone map has been uploaded to the community website. The crew applied a nitrogen treatment in Early May. A full fertilizer treatment will be applied prior to the blackout period in July.

- Neighborhood Networking (Mr. Behar): Mr. Behar discussed a few topics brought up at the last meeting. The main discussion among the neighbors was Capital Contribution.
- DAMES (Ms. Larke): The Devonshire Annual Potluck date is scheduled for Saturday, March 21, 2026.
- KRCA Board Representative (Mr. Hannon): The clubhouse roof is in the process of being replaced. The board approved to replace all the A/C rooftop units as well. Tennis Courts 1 and 2 are still under construction due to surface area issues. The oak trees in the parking area will be replaced with less invasive trees. The next KRCA board meeting is May 28, 2025.

• DTE representatives (Tyson, Carlos, Andrew, and Bismark) answered questions from residents and provided an update on the community. There's an average of 2 work orders submitted per week. At this time, the crew cannot apply fertilizer, however, they will apply Iron and Potassium to improve soil and root conditions.
