

I EXPRESSLY AGREE THAT MY PARTICIPATION IS AT MY SOLE RISK.

I agree to indemnify and to hold Honorary Captain harmless from and against any and all damages, costs, claims or demands, including reasonable attorneys' fees, made by any third party due to or arising

from or relating to your participation in this event or the violation of any term of this Agreement and Waiver.

I agree that the statutes and laws of the State of Florida, without regard to the conflict of laws principles thereof, will apply to all matters relating to this event registration, this Agreement and Waiver. I agree that exclusive jurisdiction for any dispute with Honorary Captain resides in the courts of the State of Florida and I further agree and expressly consent to the exercise of personal jurisdiction in the courts of the State of Florida in connection with any dispute including any claim involving Honorary Captain or its employees, contractors, officers, or directors.

I further expressly agree that this Agreement and Waiver is intended to be as broad and inclusive as is permitted by the laws of the State of Florida and that if any provision of this Agreement and Waiver shall be found to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and Waiver and shall not affect the validity and enforceability of any remaining provisions.
