CANDIDATE ELIGIBILITY REQUIREMENTS (Requisitos de Elegibilidad del Candidato)

1. Must be a United States Citizen
2. Must be Registered voter of the Town of Edgecliff Village as of the filing deadline
3. Must be at least 18 Years of age on first day of the term to be filled
4. Candidate for Council Must have resided continuously in the State of Texas for twelve (12) months and in the Town of Edgecliff Village for Six (6) months immediately preceding the deadline for filing for a place on the ballot
5. Have not been finally convicted of a felony for which you have not been pardoned or had full rights of citizenship restored by other official action
6. Have not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated Or partially mentally incapacitated without the right to vote
7. Must satisfy any other requirements prescribed by law for the office
