Once recognized by the Mayor, please step forward to the speaker's podium, state your name and address and speak directly into the microphone so that people in the room can hear your comments. Citizens' comments are limited to three (3) minutes unless additional time is otherwise required by law. No discussion or action may be taken on items not listed on this agenda.

A. FY 2026–2027 BUDGET AND 2026 PROPERTY TAX

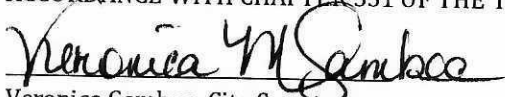
