Water and Wells

Thank you for your continued patience as we work through what has been one of our most challenging years regarding plumbing repairs in the green belt. Water is scheduled to remain on until approximately 15 October, weather permitting. As always, please adhere to the watering schedule: if you share a faucet, the homes with the higher address water Mon, Wed and Fri. The homes with the lower addresses water on Tue, Thu and Sat. All may water on Sundays.

Planting Trees in the Green Belt

Did you know residents are welcome to plant trees in our green belt as long as they have prior board approval? We lose trees each year due to storm damage and disease; planting new trees is important to keep our neighborhood looking nice. If you would like to plant a tree in the green belt, simply email heritagehillsHOA@gmail.com with the type of tree you'd like to plant and the approximate location. As always, cross check with gas, power & cable companies before you dig!
