Green Belt Fees Increase

Starting January 1st, our green belt fees will increase by 10%. For most residents, this means \$5 per quarter. The increase is necessary to deal with the ever-increasing costs associated with maintaining our green belt. It has been a very long time since the dues were raised. Thank you for your understanding on this matter.

It Takes Teamwork...

We've had several residents mention sightings of people riding ATVs or other motorized vehicles on the green belt. If you see this happening, please take note of any helpful information and notify the Enid Police.

Similarly, residents may not authorize contractors to drive on the green belt. If this happens, any damage done to underground plumbing lines may be charged to the resident.

Lastly, several residents have voiced concerns about pet owners letting their pets run lose in the green belt. The City of Enid enforces a leash law so please gather all pertinent info to make a report to the police.

This is a great venue to meet your board members, discuss any concerns regarding our neighborhood and vote in new board members. We look forward to seeing you there!

- Trash cans need to be screened from view
- Signs (other than Real Estate) are not allowed
