The meeting was called to order at 10:16.

### I. October 2, 2024 Meeting Summary:

 The October 2, 2024 Meeting Summary was accepted. It will be posted to the PEPC website.

## II. Upcoming due dates for MS4:

- We are still waiting on DEC to put out a template for annual reports that are due April 1, 2025. This template should be out by the end of December. Note post meeting, DEC release information regarding annual report format (provide link).
- Veronica proposed having the February meeting virtually due to potential weather, and we can talk about the DEC template which should be available by then. The Committee agrees.
- Corey proposed trying to set up a Q&A session for the Committee and a DEC representative in March, to ask questions regarding the annual report due April 1. The Committee agrees. Municipalities should gather questions about permits/reporting prior to the meeting. The coordinator will reach out to members prior to the next meeting to collect and organize questions for DEC.

- MCM 1&2: Public Education, Outreach and Participation
  - i. Veronica mentioned that she uses the Town Board meetings to fulfil this MCM. She lists the SWMP on the agenda which makes it available for public comment. Posting all SWMP on their website also. Most municipalities do the same.
  - ii. Corey offered to host a public meeting after hours, which would be open to the public to come in and ask any questions related to the MS4. This meeting would represent each municipality.
- MCM 4: Construction Inventory
  - i. Tom mentioned he is having trouble getting contractors to do the preconstruction meeting. He has a letter stating the contractors responsibilities sent out with the permits, but he said by the time the Town follows up, construction has already started.
  - ii. Veronica mentioned that TOB uses a contractor to do all the site inspections. They have used the same contractor for the last 10 years. They receive inspection summaries every 2 weeks for construction sites.
  - iii. Survey123 free add on to ArcGIS Online. Brookhaven, Riverhead and CCE all mentioned they already use this and that it is a great tool for conducting surveys. It could be helpful in getting construction site data.
- MCM 5: Post Construction
  - i. Brookhaven Town does not permit connections to its MS4 through design standards, which results in no post-construction inspections
- Part 8: Pathogen Areas
  - i. Brookhaven: No dogs allowed in town parks
  - ii. Southampton and Riverhead: dog waste bag stations at dog parks and walking trails
  - iii. Suffolk County: Bird population prediction models can find the flocks, and oil the eggs
  - iv. Lasers for bird mitigation is gaining popularity in agriculture Corey and Kaitlyn will look more into this

#### **III.** DEC Construction Permit:

- The new permit is due to come out at the end of January.
- Kaitlyn will make a bullet point list of new updates to the permit and distribute it to the Committee.
- This new information would be good to discuss in the March meeting with DEC.

#### IV. Outreach Plans:

Coordinators still plan to develop and produce signs for Bird pathogens

### V. Upcoming Trainings and events:

• Suffolk SWCD ESC Training to be held December 18<sup>th</sup> at Old Bethpage Village Restoration. Another training course for Suffolk will be planned for January.
