Preamble

My counsel: (To my family, relatives and friends, my Muslim brothers and sisters and all those who remain after me that: They should strive to be true Muslims in accordance to the Qur'an and the Sunnah. They should worship Almighty God Allah (SWT) alone as He should be worshipped and fear Him as He should be feared in conducting their affairs. They should love Him and His Prophe Muhammad (peace be upon him) with complete love. They should obey Him and hold fast to His Shari'ah. They should firmly establish His Deen of Islam, and die only in a state of complete submission to the will of Allah (SWT) as a Muslim. Allah says in the Quran: Surah Al-Baqarah 2: 132 And Ibrahim instructed his sons (to do the same) and Yacoob (also did say the same), "O my sons, indeed Allah has chosen for you this religion,

o so do not die except while you are in the state of Submission (to Almighty God Allah as a true Muslim)."


I wanted them to be divided according to Islamic Law.

Article I

Guardian and Durable Power of Attorney

In the situation I become mentally or physically incapacitated or unable to carry out to carry out my own duties; a separate document for the power of attorney for my medical care decision making process will be used and will be provided to those whoever may need it. Such power of attorney will be given to and administered by the same as the executor of the estate unless otherwise so noted if it is different and will be noted in the respective document.

Article II Funeral and Burial Rites

I ordain that:

- o Ghusal: Without justified delay, my body to be washed soon as possible or within 24 hours, and then wrapped with cloths free of any ornaments and other articles,
- o Salaat-al-Janazah by prayed and then buried as soon as possible, which should be done by Muslims in compliance with Islamic Rules, in a simple grave if possible easy access for my
- o No autopsy or embalmment be done on my body unless absolutely required by the law
- o Casket: My body shall be buried without a casket or any other encasement that separates the wrapped body from the surrounding soil. In the event that the local laws require casket encasement, I ordain that such encasement be of the most simple, most modest, and least expensive type possible.
- o My grave be level with the ground or slightly mounded with no construction of any kind. The marking, if necessary, should be a simple rock, merely to indicate the presence of a
- o After my burial I request for attendees to stay for few more minutes longer to pray for my forgiveness and firmness in giving the correct answers to the questioning angels and for my forgiveness from Almighty God Allah.
- o Absolutely no un-Islamic religious service or observance shall be conducted upon my death, or on my body, and that no pictures, symbols or decorations be involved with my burial or grave site.
