The Board of Directors must approve all applications before a vendor is allowed to sell at the Leavenworth Farmers Market. The Board of Directors will meet once per month to consider new applications received April-October; please submit timely to ensure approval before you would like to attend. Applications are considered for approval based on criteria found in the Bylaws to include space availability, produce or added-value product mix and accepted products as listed in the Guidelines. Applications are not considered on a first come, first served basis. Application Fee **must accompany** application. The season fee guarantees a permanent space in the market for the season. Season vendors must let the market manager know if they are not coming to market no later than noon the day before market. **Wednesday** morning season vendors are to call TBD by noon on Tuesday before market. **Saturday** morning season vendors should call TBD by noon on Friday before market. Weekly vendors are to call the market manager by 6pm the evening before the market day to ensure that space is available. Weekly vendors are not guaranteed the same space every week. Vendors are responsible for bringing their own tables, chairs, and display items. Trash **will be taken out** with all vendors at the end of market day. Trash carried in, is trash carried out. Vendors may not use city owned trashcans for their trash. Set-up times are listed in the Farmers Market Guideline but no later than 7:45 a.m. Saturdays and 7:45 a.m. Wednesdays. Electricity is available.
