RELEASE OF LIABILITY WITHOUT PHYSICAL EXAM

Witness this agreement this _____ day of _____, 2025, by and between Texas A&M IHSA Equestrian Team ("Manager") and _____ ("Rider")—and if the Rider is a minor, the Rider's parent or legal guardian, _____ ("Parent/Guardian")—agree as follows: In exchange for the opportunity to use the Manager's facilities, equipment, and services today and on all future dates, the Rider (and Parent/Guardian, if applicable), along with the Rider's heirs, successors, and representatives, agree to be bound by the terms set forth below.

1. I acknowledge that I have not undergone a formal medical or physical examination specifically clearing me for equestrian activities. I understand that participating in such activities may involve physical exertion and inherent risks. I accept full responsibility for any injuries or health issues that may occur, and I agree that the Manager is not responsible for medical treatment or costs related to my participation.
2. I understand that working with and around horses involves certain inherent risks. These risks include, but are not limited to, horses behaving unpredictably—such as running, bucking, biting, kicking, rearing, stumbling, falling, or stepping on someone—which could result in injury or even death. Horses may also react unexpectedly to sounds, sudden movements, unfamiliar objects, or the presence of people and other animals. Additional risks include uneven ground conditions, collisions with other animals, limited access to emergency medical care, and the actions of other participants, which may be negligent or beyond their skill level.
3. I recognize that horses, by their nature, can be unpredictable. I voluntarily accept all risks involved in riding, handling, or being near horses and agree not to hold the Manager responsible for any injury or loss. I agree to follow all rules and safety guidelines provided by the Manager. I also confirm that I have accurately shared my riding experience and skill level with the Manager and understand that my ability directly affects how a horse may behave.
4. I release the Manager, its representatives, staff, and volunteers from any and all claims for personal injury or property damage, including claims that might arise from the Manager's own negligence (to the extent permitted by state law). If I choose to file a claim or lawsuit in violation of this agreement, I will be responsible for all legal costs and attorney's fees incurred by the Manager in defending against it.

5. I further agree to defend, indemnify, and hold harmless the Manager from any claims, demands, lawsuits, damages, costs, or expenses—whether or not legal action is filed—that may arise from my participation or presence on the Manager’s property.
6. Any legal action arising from this agreement must be filed within one (1) year of the incident giving rise to the claim. I also agree that any claim for property damage shall be limited to \$250 in value, and claims for non-economic damages (such as pain and suffering) shall be capped at \$10,000.
7. I knowingly waive the protection of any law that might otherwise prevent this release from applying to claims I may not be aware of at the time I sign it. I understand this release applies to both known and unknown claims related to my involvement with the Manager and its facilities.
