✗ **S398 –PARENTAL CHOICE REMOVED** - REMOVING PARENTS FROM DECIDING- Placing the burden on 14 year old minors to make medical decision without real informed consent. **(Pulled for now)**

✗ **A1603 –MANDATORY HPV VACCINE** - Aimed at children grades 6-12, **without Informed Consent Issue:** Causes infertility in young girls, anxiety and neurological complications and many more illnesses.

✗ **S902/S903 – MANDATORY VACCINES, including all vaccines not yet created** - Aimed at REMOVING PARENTS FROM DECIDING, utilizing MEDICAL EXEMPTIONS AND COMPLETELY REMOVING RELIGIOUS EXEMPTIONS - Removes INFORMED CONSENT!

✓ **SR15** - Urges Congress to compel Department of Health and Human Services to fulfill its obligations pursuant to the National Childhood Vaccine Injury Act of 1986.
