

## FEATURED EMPLOYEE

Jim Yorks is our featured employee. Jim has worked for the Township for 5 years. He is currently on the Zoning Commission and was previously a member of the “Safety Task Force”. As a member of the Zoning Commission, Jim needs to study and be familiar with the Amherst Township Zoning Resolution. The Zoning Commission makes decisions on rezoning, handles special requests from individuals on rezoning, and reviews “Site Plan Reviews”, signs, and text changes to the Zoning Resolution. They are also looking at the goals and vision of the overall “Comprehensive Use Plan” for the future of the Township. The Zoning Commission usually meets once a month. However, with the Quarry project, Conservation Development, the “Comprehensive Use Plan” and the “Route 58 Corridor Plan”, the last two years have been very busy with many extra meetings and public hearings.

Jim enjoys meeting new people in the township as well as working with his fellow commission members, the township trustees, and other county officials. He finds the job to be gratifying, as he is made aware of future development projects (like the “Quarries”) and can be a part of the design phases so that the township’s concerns can be addressed prior to breaking ground. He also appreciates the opportunity to give back to the community by sharing his talent in an effort to promote quality, controlled growth. Jim finds the job to be difficult when they are unable to grant an applicant’s request and when weighing private property owner’s zoning rights vs. enforcing development standards in the best interest of the township as a whole. Jim is a registered architect and president of the A & E firm of James A. Yorks Architect and Associates in Amherst, Ohio. He is responsible for directing design, development and managing the consulting and construction administration of the studio’s commissions. For the previous 15 years, he was employed by Star Builders Inc., during which time he held many positions such as carpenter, project manager, vice president, and principle architect in the commercial/industrial facilities development areas. 
paper boy, a baker, a grounds care taker, a gas station attendant, a sign painter, a draftsman, a product designer, a furniture designer, and an interior designer.

## Allied Waste Services (BFI) Offers Senior Discount

If you are an Amherst Township senior who meets all of the requirements listed below, you are eligible for a discount that can save you approximately \$80 per year on your trash pickup bill:

- ✓ You have a Golden Buckeye Card.
- ✓ You are not employed outside the home.
- ✓ You have no children or boarders living with you.
- ✓ You are limited to 2 cans or 3 bags, weekly

To receive the discount, you must drop off or mail a copy of your Golden Buckeye card (showing both sides) along with acknowledgement that you meet the above criteria. **Do not** send this information with your bill, as it goes to a different location. The mailing address is:

## “ICE” Cell Phone Program

“In Case of Emergency”

With the popularity of cell phones and their use, the Lorain County Sheriff’s Office is making residents aware of a very simple program designed to aid emergency responders in their efforts to identify victims whose identity is unknown and/or in need of having a responsible person contacted. This program is totally voluntary and can be accomplished without the aid of your cellular provider.

The program known by the acronym I.C.E. for (In Case of Emergency) was first developed by the East Anglian Ambulance Service in England. The premise of the program is very simple. Cell Phone users are requested to make an entry into their cell phone’s address book with the indicator ICE. This ICE number listed in their cell phone address book should contain the phone number as a next of kin or other person that the subscriber would like to have contacted in the event of an emergency. This entry could be made even more specific and equally helpful by denoting the ICE entry as: ICE MOM, ICE DAD, etc. for quicker reference. Subscribers are encouraged to make more than one ICE entry in their address book in the event that one or more entries cannot be reached.

Often, people are in possession of their cell phones even when not carrying personal identification as might be the case when involved in athletic activities such as bicycling, running, walking, etc. It would also help out police, fire, ambulance, or hospital personnel if someone is involved in an auto-accident and they are unconscious, this gives emergency personnel a resource to reach out to the most important people.

The ICE program concept of sticking this information in your cell phone is not to be the “be-all-end-all” for contact of the next of kin. It’s just an extra thing you can do that doesn’t cost anything.

An additional benefit to deputies and police would be to provide officers the ability to return found cell phones to their owners when lost. Law Enforcement agencies routinely come into the possession of lost cell phones that are, at times, difficult to return to their owners.

When a permit is applied for before the start of construction, the fee will be reduced by 50%. Be sure you or your contractor has obtained a permit.

## Medicare Changes for 2006

**Correction from Fall issue:** When you do not join during the open enrollment period, your premium cost will go up **at least 1%** per month for every month that you wait to join, not **10%** as stated in the last issue. Like other insurance, you will have to pay this penalty as long as you have Medicare prescription drug coverage.

The open enrollment period begins **November 15<sup>th</sup> and runs through May 15<sup>th</sup>**. If you join after May 15, 2006, the **next open enrollment period is November 15, 2006 to December 31, 2006**.

However, coverage for people who enroll during this period will not take effect until **January 1, 2007**. You may be healthy now and not using any expensive medication, but if you need coverage later on when health problems come, you may be in for a **major** monthly out-of-pocket expense.

## Timely Information for Seniors & Their Children

Periodically we receive a newsletter from “Cornerstone Consultants, Inc” of Wellington. A recent issue had information that was worth passing along to our residents. So with the permission of Tama McAleese, president of Cornerstone Consultants, we hope you will find these two articles helpful.

Tama hosts a call-in radio program (888-281-1110) on Saturday mornings from 10-11 AM on WHK, 1420 AM. This is a good place to gather financial information or ask questions.

### Free credit reports

Every year “financially-fit” consumers are turned down for credit or are otherwise damaged by incorrect, incomplete, misleading, or fraudulent credit data.

Since paying your bills on time does not protect you from reporting errors due to sloppiness, mistaken identity, or fraud, it is vital to investigate who has been inquiring about you, if credit cards were issued in your name without your permission or maybe even sent elsewhere, and for any entries that do NOT belong in your credit record.

Thanks to a federal law, you can receive a **free** credit report on [www.annualcreditreport.com](http://www.annualcreditreport.com), which is a Web site set up by the major credit bureaus. If you find inaccurate or fraudulent information, instructions are given for how to dispute the questionable entries.

If you pay bills on time, have no outstanding credit balances, and are not planning to borrow in the near future, **why** should you **bother**? Because your credit history can be used by companies to determine your rates for other purchases such as auto and homeowner insurance.

### How to Prepare For an Emergency or Unexpected Event

Here are some items to have available for immediate access and to make your family representative or children aware of:

- ✓ A cash stash for emergency use for purchasing necessary items or to transact temporary business.
- ✓ Two sources of emergency funds for 3 to 6 months of budgeted expenses with check-writing privileges (ex. banks, credit unions, or money market mutual funds).

- ✓ A property and auto insurance plan with an extra personal liability umbrella policy if you have accumulated valuable assets.
- ✓ Up-to-date estate planning documents and copies of all beneficiary designations for financial accounts and insurance policies. Snowbirds should keep originals of wills and financial and health Power of Attorneys in a fire-retardant lock box that can go with you when you leave home for the winter.
- ✓ A current list of all credit cards, bank accounts, investments, license plate numbers and car VINs so you can react quickly to protect your personal life, property and assets if a theft occurs?
- ✓ Make sure that you post a list of address and phone numbers for important people like your doctors, lawyer, clergyman, insurance agent, and emergency contact and for the local fire and police departments near the phone. Give your designated family representative a copy of this list plus the following: 1) a list of your personal financial accounts numbers and passwords, pertinent representative names and phone numbers, 2) a list of what bills need to be when and how they are paid (on-line banking, check (where you keep your checkbook) or electronic fund transfer (**remember**: they will need to be designated on the accounts to be able to access them), 3) a record of your computer passwords, how to access important files and where to find your backup file disks, and 4) a list of important keys and where the items are they go to.
- ✓ Labeled master key board that includes keys for all cars, house, out buildings and other important items such as a lockbox, safety deposit box, home safe or off-site storage facilities.
- ✓ Lockbox with key attached so you can access its information away from the home. Store it near a fire exit along with several flashlights and lots of charged batteries.
- ✓ If you have to suddenly flee home, do you keep your cars’ gas tanks nearly full and are there county maps in each which show all the area’s back roads?
- ✓ List of each family member’s vital medications should be taped to the refrigerator door for easy access in case they need to be rushed to the hospital.
- ✓ A communication system is a must during disasters or a family crisis. Do all family members know where to go or whom to contact?
