Crime Watch Security Flasher 911 System

According to our Community Policing Officer, Deputy Joe Greiner, 20 more of these adapters are now available upon request. Once emergency services have been called (Police, Fire, and Ambulance), with the use of the "Crime Watch Security Flasher 911 System" citizens of Lorain County can immediately have their residences identified by the flashing light. Officers will instruct the recipients of the "Crime Watch Security Flasher 911 System" that its use should be for emergency situations only, and are not intended for routine delivery style occasions. Please advise your children as well. This device should be treated the same as calling "911". If a Deputy observes a house with this device activated, a check on the well being of the occupants will be done, even if there is not call for emergency service listed with the Police, Fire, or EMS. These adapters install into a standard light socket and operate off the same switch as the standard porch light. They will be provided free of charge to qualified candidates of Lorain County, courtesy of the Lorain County Sheriff's Office. This number is to the "Community Policing Officer" Office and is not monitored 24 hours a day.

Twp. Bulletin Board

Scheduled meetings and Trustee Work Sessions are regularly posted in the bulletin board at the Township Hall. These are public meetings and residents are welcome to attend.

Road and Storm Drainage Improvements

Approximately \$145,000 was expended in 2007 to improve various Amherst Township Roads and Storm Sewers. The largest project was the Broadway, Taylor and Tenney Road reconstruction and storm tile replacement. Additional storm system cleaning and tile replacement occurred on Tina Lane, Kay Drive, Hornyak Court, Oaknoll, Rosedale and Bechtel Road, and joint sealing was completed on Dewey and Rice Roads.

A more ambitious Road and Storm Drainage program is planned for 2008, at an estimated cost of \$430,000. The major project in 2008 will be concrete slab replacement for various roads in the Hidden Valley Subdivision, at an estimated cost of \$295,000. Amherst Township has applied for a combination of grants and loans for the Hidden Valley area project, but is currently on the "un-funded" list, meaning this project is dependent upon available funding sources.

Additional 2008 projects include "Chip & Seal" of Tina Lane, Hornyak Court, Fowl Road and Bechtel Road. Park Avenue will be milled and repaved. Stang Road, Oberlin Road, Balsam Drive and various Hidden Valley Subdivision streets will undergo crack sealing. Roadside ditches and tile along Oberlin, Bechtel and Dewey Roads will be cleaned, along with general maintenance and cleaning of the various catch basins and storm sewers. Street Sweeping will be conducted within the higher density residential sub-divisions in the early spring.

Every effort will be made to maintain through traffic during these road and drainage improvement projects, but some detours may be necessary. Please use caution when driving through or near these various projects.

PERMITS REQUIRED

As Springtime arrives, residents are reminded that permits are needed for the items listed below. When a permit is obtained before the start of construction, the fee will be reduced by 50%. Be sure you or your contractor has obtained a permit. **Payments must be made by <u>check only</u>. Cash is not accepted.**

Please contact Don Gargas, Amherst Township Zoning Inspector for these permits. Building inspections through the Lorain County Building Department may also be required. Office hours for the Zoning Inspector are from 8 a.m. to 11 a.m. on Mondays, Wednesdays and Saturdays. He can be reached at 988-5866. Voice Mail is checked daily.

The Amherst Township Zoning Inspector can assist you for both of these requirements. A building "<u>permit</u>" from the township is required **before** applying for the building "<u>inspection</u>" from the county. Permits for both the township and the county may be viewed on the township's website under "zoning".

Recycling Incentive Contest

Newspapers are to be placed in a separate blue bag from the rest of the recyclables. Also, please rinse all food and beverage containers before placing them in a blue bag.

Residents are reminded that as of March 1, 2003 animals are not permitted in the Amherst Township Park. Whoever violates this resolution is guilty of a minor misdemeanor and shall be prosecuted (ORC Section 511.32).

Also as a reminder, vandalism at the Amherst Township Park is prosecutable. Violators will be charged with Criminal Vandalism according to ORC 2909.05. This is a felony offense and carries a fine of \$2500. This will be strictly enforced. The township park is being patrolled by the Sheriff's Department.

2007 Year-End Report

<u>Meal Program:</u> Our volunteers and director drove 4971 miles to deliver 3520 meals to 32 participants.

Transportation: 19 trips, 430 total miles.

<u>Support Services</u> (one-on-one work with clients): We spent 115.82 hours filling out forms and helping clients get services they need by assisting them with phone calls to agencies or going to appointments with them. Seventy-Five (75) of these hours were for the Medicare counseling program administered by the Ohio Senior Health Insurance Information Program (OSHIIP).

Director Schmitkons worked 1233 hours with 22% of her time spent on the meal program and 23% spent on the "one-on-one" work with 100 consumers. She drove a total of 2477 miles.

Highlights of 2007:

- Funding from the WRAAA & CDB grants saved the township \$5,050!
- With the encouragement of the Lorain County Office on Aging, we extended our service area to include Henrietta Township. The Henrietta Township trustees voted to join us and were included in our 2008 grant applications. Meal and support services were extended to that community during the fourth quarter of 2007.
- AVI Food Systems, was chosen to provide meals for 2008. While the new plan will not be able to meet special dietary needs, it does provide more flexibility and plan options. Residents may select from one of 3 plans – entrée, sandwich and soup, or soup and salad.

REBATE INFORMATION

Seniors need to know that in order to receive a refund from the "stimulus package rebate", they need to file a 2007 income tax return, even though they may not have filed an income tax return in recent years. To qualify, Social Security income must be at least \$3,000.

Care Choice Ohio

Care Choice Ohio is a consultation program designed to promote long-range planning for health and financial care for Ohio's older population. Far too often, plans for the care of elderly family members and friends are put off into "the future". Consequently, these difficult and often stressful decisions are frequently made during a crisis situation and in great haste.

Not long ago in Ohio and nationwide, long-term care for older persons most often meant only care in a nursing home. Not anymore. When it comes to long-term care, Ohioans have more choices than ever before. Now, thanks to a statewide assistance program called Care Choice Ohio, finding out about available services can be quick and convenient. Care Choice Ohio has been initiated specifically to help seniors and their family members plan earlier for long-term care needs. Anyone, regardless of age or income, can take advantage of this free service offered by the Western Reserve Area Agency on Aging. Specially trained consultants are available to make friendly, personalized home visits to assess you or your loved one's circumstances and needs. They will discuss eligibility for programs and will inform you and your family of the long-term care services and long-range financial planning options existing in Ohio.

Digital Television Transition

On February 17, 2009 the nation's television broadcasters will switch television signals from analog to digital transmissions. Not to be confused with "high definition" (HD) or "flat screen" or other modern television features, **digital refers to the way that television broadcasts are delivered to your TV set.** Older TVs only pick up analog signals so when broadcasters switch to digital transmission, they will not be able to receive free, over-the-air signals without doing **one** of the following:

- Purchase a converter box to attach to your existing TV. Retail price is expected to be \$55-\$75, but government coupons worth \$40 will be available early in 2008. The converter will sit on top of your TV and change the digital signal to analog so your TV can "read" it.
- 2) Upgrade your TV to new digital model.
- 3) Subscribe to a cable or satellite service.
