# Solid Waste and Recyclables Collection News – Past & Future

Amherst Township is a member of the Lorain County Solid Waste and Recyclables Collection Consortium. The Consortium of twelve Lorain County communities was formed in 2013. These communities recognized that their residents were paying too much for residential waste collection, hauling and disposal when benchmarked against the cost paid by other communities for similar services in the region. The residents of the Consortium communities had been serviced by the same waste hauler for many years without significant competition for the provision of residential curbside recycling and waste collection services.

The purpose of the Consortium is to provide a collective competitive bidding opportunity to political subdivisions for securing solid waste and recyclable material collection and disposal services. Ohio Revised Code section 505.27 provides the lawful authority for the Amherst Township Board of Trustees to select an independent contractor to be the exclusive provider of residential curbside recycling and waste collection services.

In late 2013, the Amherst Township Board of Trustees selected Rumpke Waste and Recycling Services as the lowest and best Bidder for the collection, transportation and delivery for disposal or processing of residential solid waste and recycling materials for the five-year period from January 1, 2014 through December 31, 2018. Rumpke’s 2013 bid included the provision of 96-gallon solid waste and 64-gallon recyclable materials collection containers for all participating residents at a cost of \$53.25 per quarter, plus a \$1.26 per quarter Consortium administrative fee. Residents that did not generate a lot of waste could choose a smaller 64-gallon or 32-gallon solid waste collection container at a quarterly savings of \$5.46 and \$10.35 respectively.

The 2013 agreement between the Township and Rumpke included a fuel price adjustment formula, which would adjust when the “*Weekly On-highway Retail Fuel Price, All Types for the Midwest Region,*” as published by the United States Department of

Energy, changed by an average amount during the preceding quarter of at least \$0.25 per gallon from a base price established in the bid specifications. The 2013 base fuel price was \$3.967 per gallon. As diesel fuel prices have declined since 2013, residents currently receive a fuel surcharge credit on their quarterly invoice.

Because of the difficulties encountered when changing residential curbside recycling and waste collection service contractors during the coldest month of the winter season, the Amherst Township Board of Trustees extended their contract with Rumpke an additional three months, through March 31, 2019, ensuring any future change of collection service contractor would occur under slightly warmer conditions.

The Consortium solicited bids for the 5-year contract period from April 1, 2019 through March 31, 2024. Kimble, Republic and Rumpke provided bids for the contract period. On January 8, 2019, the Amherst Township Board of Trustees agreed to award the bid to **Rumpke Waste and Recycling Services** as the lowest and best Bidder. The estimated quarterly cost per residential unit is displayed in the chart below. The 2018 base fuel price is \$3.018 per gallon.

Amherst Township’s participation in the Consortium has proved to be a success for township residents. Average annual savings per residential unit amounted to \$120, or more than \$200,000 annually for all Amherst Township residential units. In addition, the Township saved over \$6,000 annually in the disposal of Township solid waste, money better spent on the maintenance of township roads. Over the previous 63-month contract period, Amherst Township residents have saved over \$1-million dollars! An added benefit resulting from the introduction of competition for solid waste and recyclable material collection services in Lorain County was a price reduction to non-Consortium members.

The curbside solid waste and recyclable collection pricing for the next five-year contract period has gone up, but these prices are still less than we paid in 2013!




# UPDATED “AMHERST TOWNSHIP” WEBSITE

# PERMITS REQUIRED

As Springtime arrives, residents are reminded that permits are needed for the items listed below. When a permit is obtained before the start of construction, the fee will be reduced by 50%. Be sure you or your contractor has obtained a permit. **Payments must be made by check only. Cash is not accepted.**

## DRIVEWAY APRONS

Residents are also reminded that when a road project requires modification of a drive apron, as a general rule, the drive apron modification will be completed with the same material as the road project. In all cases, maintenance of a drive apron is the responsibility of the property owner.



## Planting in Road Right-of-Way



Residents should not landscape or plant near road intersections or inside the road right-of-way. Generally, the road right-of-way is 30 feet on either side of the centerline of the road. If planting occurs in this area, homeowners should not be disappointed if plants are destroyed or removed due to maintenance or repair. Trees should not be planted in this area. If storm sewers run across your property, it is better not to plant trees, shrubs, or other vegetation too close to these lines in order to minimize the chance of any roots penetrating these lines and causing a blockage. Please be aware of any visibility issues that may be caused due to trees and shrubs growing near an intersection or the road right-of-way. Property owners are also responsible for removing dead branches of a tree that overhangs the road.

# Lorain SWCD

The Lorain Soil & Water Conservation District (**LSWCD**) is having their **4<sup>th</sup> Annual Big Tree Contest**. This year they are looking for Lorain County's biggest Eastern Cottonwood (*Populus deltoides*). Each tree will receive a score based on trunk circumference, crown spread, and total height to determine the winner.

The annual National Association of Conservation Districts (NACD) **Poster Contest** for 2019 is open for submissions for public, private, and home schooled students in grades K-12. The contest starts at the local level, moving to the state, and then to national competition. Cash awards will be given for 1<sup>st</sup> (\$30) and 2<sup>nd</sup> (\$20) place in the following categories: K-1, 2-3, 4-6, 7-9, and 10-12. Winners at the local level will be sent on to the State contest. The top three posters in each grade category in the National contest win monetary prizes of up to \$200! LSWCD is also holding a 1<sup>st</sup> annual **Photo Contest**. This year's categories are landscapes and wildlife. All entries must be submitted by August 9, 2019.

A **Pond Management Clinic** will be held on Thursday, April 25<sup>th</sup> from 5:30-7:30 pm at the Lorain County Agricultural Center located at 42110 Russia Road, Elyria. Pizza and drinks will be provided. Reservations are required with a registration fee of \$5.00 (cash or check only). To RSVP for the clinic, contact the office at **326-5800**.

The LSWCD **Spring Fish Sale** is underway. They are now taking orders for fingerling-size fish for stocking ponds. Largemouth Bass, Bluegill, Hybrid Bluegill, Channel Catfish, Yellow Perch, Redear Sunfish (Shellcrackers), Fathead minnows, Japanese Koi, and Triploid White Amur are all available. Order deadline is May 6, 2019.

The 2019 **Seedling Sale** is underway and includes a variety of Evergreens, Hardwood Species, Shrubs, and Perennials. Order pick up date is on one day only, April 12<sup>th</sup>.

# LCSWD COMMUNITY GRANT

The Lorain County Storm Water Advisory Committee (SWAC), representing the Lorain County Storm Water District (LCSWD) managed by the Lorain County Commissioners, has budgeted funds for projects related to Storm Water improvements since 2011, with \$400,000 being budgeted for 2019 projects in the unincorporated areas of Lorain County.

Amherst Township has established the “Engle Ditch Drainage Improvement and Flooding Abatement” project as part of their Storm Water Management Program. Due to the high cost of this project, it has been divided into two Phases.

Amherst Township has been awarded \$64,410 as part of the 2019 LCSWD Community Grant to be used towards the “Engle Ditch Drainage Restoration Project – Phase Two”. Total cost of the project is estimated to be \$111,035 with Amherst Township being responsible for the remaining \$46,625.

The “Engle Ditch Drainage Restoration Project – Phase Two” will include dipping, cleaning, hauling away the spoils, seeding and mulching of a 25-foot easement along a portion of approximately 4,500-feet of the Engle Ditch, beginning at the northeasterly ending point of “Phase One” of the project, extending in a northeasterly direction, then turning in a southeasterly direction toward Stang Road. The Phase Two project will also include a ditch crossing.

This project is expected to be bid out in May, with work anticipated to begin August of 2019.

## NOPEC Grant

Amherst Township is receiving a NOPEC (Northeast Ohio Public Energy Council) Energized Community grant in the amount of \$16,756.00 for 2019. NOPEC and NextEra value our community’s membership and are awarding this grant to help our community achieve even greater savings. These grants are offered to help implement energy efficiency or energy infrastructure projects that will benefit our community for years to come.

# 2019 Road Projects

## “Chip & Seal” Program

For the 4<sup>th</sup> year, the Lorain County Engineer’s Office is once again offering all townships the opportunity to participate in the 2019 county-wide “Chip & Seal” bid program. Amherst Township has chosen to participate in this program and has submitted their request to have **Bechtel Road** (between Albrecht Road and SR 113) be included as part of the bid. By combining projects from various communities the engineer is able to get a lower base price due to the increased volume.

The Lorain County Engineer has estimated the Bechtel Road project to cost \$19,770 for the “Chip & Seal” finish layer. Cost estimate for any base repair and pre-leveling will be determined if this preparatory work is determined to be required.

It is the goal of the county engineer to have the bid document ready by early April so that a notice to proceed can be issued in June to the successful contractor.

## OPWC ROUND-33

Amherst Township has been awarded financial assistance for two road projects in 2019 from the OPWC Round-33 funding program.

The two projects include concrete replacement of approximately 510 feet of roadway on Hidden Tree Lane and the repaving of approximately half of Stang Road. The Stang Road repaving project will be done as a joint project with the county and will include replacement of a bridge on Stang Road.

These projects are expected to be bid out in April, with work anticipated to begin after July of 2019.

## FIRE SERVICE CONTRACT

Amherst Township has signed a 3-year Fire and EMS First Responder Service Agreement with the City of Amherst, who will provide fire protection and “First Responder” emergency medical service for the unincorporated area of the township north of the Ohio Turnpike. This 3-year term began on January 1, 2019 and will end on December 31, 2022.

# **AMHERST TOWNSHIP** **PARK REMINDERS**

Residents are reminded that as of March 1, 2003 animals are not permitted in the Amherst Township Park. Whoever violates this resolution is guilty of a minor misdemeanor and shall be prosecuted (ORC Section 511.32).

Also as a reminder, vandalism at the Amherst Township Park is prosecutable. Violators will be charged with Criminal Vandalism according to ORC 2909.05. This is a felony offense and carries a fine of \$2500. This will be strictly enforced. The township park is being patrolled by the Sheriff's Department.

## Exercise & Your Brain



Studies have shown exercise and a healthy diet may increase mental sharpness and reduce mental decline due to aging. Growing evidence indicates that people can reduce their risk of cognitive decline by adopting key lifestyle habits. It's never too late to incorporate healthy habits.

Exercise can be as easy as walking 20 minutes, three times a week or riding a stationary bike for 30 minutes three times a week. If you are at a risk for falls due to medication, vertigo, or weakness; you can purchase a stationary pedal exerciser that you can use from a chair or use table top to strengthen your arms.

Seniors, who exercise regularly, three times a week, saw improvements in their brain's ability to pay attention, regulate behavior, get organized and achieve goals.

The seniors who adopted exercise and healthy diet changes, including eating more fruits and vegetables, showed somewhat larger gains cognitively.


