PERMITS REQUIRED

Residents are reminded that permits are needed for pools, decks, porches, patios, gazebos, fences, ponds, signs, garages, new construction, building additions, accessory buildings, and driveways. When a permit is obtained before the start of construction, the fee will be reduced by 50%. Be sure you or your contractor has obtained a permit. **Payments must be made by check only.** Cash is not accepted.

Please contact Remi Cerrone, Amherst Township Zoning Inspector for these permits. Office hours for the Zoning Inspector are from 8 a.m. to 11 a.m. on Mondays, Wednesdays and Saturdays. He can be reached at 988-5894. Voice Mail is checked daily.

Attention! Hidden Valley Residents As a reminder, please do not rake leaves onto the street as it restricts water flow into the catch basins when it rains, causing drainage problems for you and your neighbors! The township does not pick up leaves. However, you can bring leaves and other yard waste to the Township Yard Waste Recycling Center, located across the road from the Township garage, for disposal.

Preparing for Winter

- As a safety issue, please do not pile snow around fire hydrants. It is best to keep hydrants clear of any snow, excess mounding of soil, or plants.
- Also, when cleaning your driveways, do not plow or shovel snow onto the streets after the Township/County has plowed.
- Mailboxes should be inspected to make sure the posts are in good condition before the winter snowplowing begins.
- Be aware that the bridge decks freeze before the pavement does, causing them to be slippery even when the roads are clear.

November is the best time to get your flu shot in northeast Ohio. A flu shot in November offers you the best protection through the peak flu season in Northeast Ohio.

For Amherst Township residents, the nearest clinic will be held on Friday, November 8th from 10:00 a.m. to 12:00 p.m. at the Old Stone Evangelical Church located at 553 S. Main Street in Amherst.

Come to flu shot clinics prepared. Registration forms can be downloaded from the website. Bring a photo ID and your insurance card. LCPH accepts most private insurances, Medicare Part B, and Medicaid. No one will be turned away for inability to pay.

"ATV" USE ON PUBLIC ROADS

You may wonder what regulations the Ohio Revised Code (**O.R.C.**) contains regarding all-terrain vehicles (**ATV's**). Generally, ATV's are considered "All-Purpose Vehicles" under the Ohio Revised Code and are regulated as such (ref O.R.C. §4519.01(B)). This category also covers all season vehicles, mini-bikes, and trail bikes.

O.R.C. §4519.40 describes where an operator is prohibited from driving all-purpose vehicles, off-highway motorcycles, and snowmobiles, including:

- On limited access highways, freeways, or their rights-of-way;
- On any private property without permission of the owner;
- On state lands or waters (i.e. parks, recreational areas, campgrounds, etc.), unless a sign has been posted permitting usage;
- On any railroad tracks or rights-of-way;
- While transporting a firearm or bow that is not unloaded and securely encased;
- For the purpose of chasing, pursuing, capturing, or killing any animal or wild fowl; and
- From sunset to sunrise, unless lights are displayed.

A violation of this section is a fine not less than \$50 and not more than \$500 and/or imprisonment for not less than 3 days and not more than 30 days.

Under O.R.C. §4519.41, an operator of an all-purpose vehicle may travel to cross a highway (other than a limited access highway), on a county

or township highway whenever the local authority permits, alongside a street or highway for a limited distance to a riding area, or on the berm of a highway (other than a limited access highway) when it can be done safely.

A local authority cannot require the registration or licensing of any all-purpose vehicle (or snowmobile or off-highway motorcycle) as those items are required to be registered with the registrar of motor vehicles subject to certain exceptions under O.R.C. §4519.02. Those exceptions include, for example, a snowmobile or off-highway motorcycle that is operated exclusively on the owner's property or an all-purpose vehicle that is used primarily for agricultural purposes when the owner qualifies for the CAUV tax credit. While ATV registration and licensing falls under the state, townships do have the ability to regulate all-purpose vehicles on streets, highways, public property under its jurisdiction, and within the reasonable exercise of police power (O.R.C. §4519.48). Signage may be posted in townships to help owners understand where they can and cannot operate an ATV.

DOWNED TREES



If residents notice a fallen tree that is impeding or blocking the roadway, they should first call the Sheriff's non-emergency number at **329-3710**.

The Sheriff's dispatch will be able to contact the appropriate entity to address the issue, be it township, county, city, and/or utility.



FUNDING AMHERST F.A.G.E. COMMUNITY ENHANCEMENTS



F.A.C.E. is looking for new board members that have a vision and passion for our community. Members must live, work, or own property in Amherst Township. The Board normally meets 4 times a year for a short meeting. If you are interested in being a part of this non-profit organization, please contact one of the Amherst Township Trustees. Funding Amherst Community **Enhancements** (F.A.C.E.) is a non-profit corporation created by the Amherst Township Trustees to seek donations, grants, and volunteers to work on projects to enrich the lives of all citizens in Amherst Township and the surrounding communities.

F.A.C.E. was formed in late 2004. They had their first board meeting on February 15, 2005 and by mid- summer they received acknowledgement from the IRS that they could accept donations that would allow the donor to take a tax deduction.

Over the years F.A.C.E. has held 8 "Wine Tasting Events" and 2 "Amherst Township Lake Erie Crushers Day" in Avon in order to raise funds. They were also involved with the "Township Open House and Silent Auction" for the newly renovated Township Hall in 2010. This event alone raised over \$2800 for park improvements. They also worked with grant writer Malcolm Peel to apply for

several grants for the additional walking path in the Middle Ridge Road Township Park.

The donations that F.A.C.E. raised have been used for many various Township Park improvements including picnic tables, park benches, flower beds, mulch, and a TOT swing set with two TOT swings. They also paid for the "Veterans War Memorial" that is on display in the Township Hall as well as contributing \$500 towards the lighting of the "Veterans Mural" in downtown Amherst.

This summer FACE paid \$470 towards the labor and material to stain the pavilion in the Amherst Township Park located on Middle Ridge Road.

STANG ROAD CLOSURE

Lorain County Engineer Ken Carney announced the closure of Stang Road, between Oberlin Road and West Ridge Road, for the replacement and resurfacing of bridge #0038.

The cost of the project is \$319,450, with 89% funding from the Ohio Public Works Commission (OPWC) and the remaining 11% funded by Lorain County Motor Vehicle Tax monies and Amherst Township. The work is being completed by Denes Concrete of Wellington, Ohio.

The work began on Monday, September 9^{th} , and is expected to be completed by Friday, November 8^{th} , weather permitting.

Local traffic will be maintained. Detour signs will be posted. Your cooperation during construction is greatly appreciated.

Safety Tip

When walking or riding along roadways, always wear something reflective during the early morning, dusk and evening hours. assume that drivers can see you! Carrying a flashlight will also make you more visible to drivers. For added safety, when a vehicle is passing you, move over to the edge of the road or onto the lawn.

Burning Prohibited

MEDICARE OPEN ENROLLMENT

Open enrollment begins October 15th and runs thru December 7, 2019.

During Medicare's annual open enrollment, seniors can:

- Stay on Original Medicare and shop for a stand-alone "Part D" prescription drug plan. Select a Medicare Advantage Plan, which provides comprehensive health benefits, typically including prescription drug coverage.
- Determine if existing coverage will continue to meet health insurance needs.

LOW-INCOME SUBSIDY

Low Income Subsidy (**LIS**) is a Medicare program for individuals with limited income. This program helps to pay for your Medicare "Part D" prescription plan's premium, deductible, and co-pays.

You will automatically qualify for "Extra Help" if you have one of the following:

- Medicare "Part B" premium help from the state
- Medicare and Supplemental Security Income (SSI)
- Medicare and Medicaid

If you already receive **LIS** please be aware that if your income or resources change, you may not automatically qualify for help next year.

<u>VOLUNTEERS</u> <u>NEEDED</u>



Can you spare 1 hour a week or a month to help your senior neighbors? Our meal program is in need of volunteers to township deliver meals to senior residents. We have an immediate need for "Friday" drivers. The routes are approximately 16 miles long and take about 45 minutes to complete, anytime between the hours of 10:30 a.m. and Mileage is reimbursed at \$0.58 If you are interested in per mile. volunteering, please call the office.

MEDICARE SAVINGS PROGRAMS

There are 4 programs available to those with low income and low assets to help pay for health care coverage.

- QMB Qualified Medicare Beneficiary:
 > Works as a free Medicare supplement policy
- SLMB Specified Low Income Medicare Beneficiary:
 - ➤ Pays the Medicare "Part B" premium
 - > Retroactive "Part B" premium amounts for each of the last 3 months
- **QI** Qualified Individual:
 - ➤ Pays the Medicare "Part B" premium
- QDWI Qualified Disabled and Working Individuals:
 - ➤ Helps pay the "Part A" premium if you are under 65, disabled, and no longer entitled to free "Part A" solely because you returned to work

"Resources" include money in a checking or savings account, stocks, bonds, home, car, life insurance policies, IRA's, household income, burial plot, or burial expenses up to \$1500 per person.

FRAUD & IDENTITY THEFT PROTECTION

During Medicare open enrollment, seniors need to be aware of predatory sales practices and Medicare scams. These scams come in the form of unsolicited calls asking for personal information. such your Social as Security number or Medicare number. Please remember to never give out any personal information over the phone including your address, credit card or banking information.

Another recent scam involves offering you "free" genetic tests. Scammers claim Medicare will cover the test in order to get your Medicare Number and

then use it to commit fraud and identity theft. They're targeting people through telemarketing calls, health fairs and even knocking on doors.

Only a doctor you know and trust should order and approve any requests for genetic testing. If you get a genetic testing kit in the mail, refuse the delivery or return to sender unless your doctor ordered it.
