Stormwater Flooding, Backup, and Cleanliness

Several entities are responsible for the Storm Water drainage system in Amherst Township. The Amherst Township Road Crew is responsible for maintaining over 20-miles of storm water drainage along township roads, parks and cemeteries; the Lorain County Engineer is responsible for the storm system along County Roads; the Ohio Department of Transportation is responsible for drainage along State Roads; the Ohio Turnpike Commission takes care of Turnpike drainage; and residents and businesses are responsible for drainage on their private property.

The Road Crew regularly inspects the Township drainage system for problem areas, identifying tiles clogged with tree roots and debris, failed drainage tiles, and open ditches that must be cleared and profiled. During heavy rain events, the Road Crew can be found clearing catch basins of surface debris and placing "Road Closed" signs in flooded areas. Even with regular inspection of the drainage system, sometimes there is no fix to rain events that overwhelm the storm water system. Sometimes, Mother Nature just wreaks havoc.

In the past month, the Township Road Crew has jetted through the storm sewer on Hidden Valley Drive between Briar Court and Moss Canyon. Phase Two of the Engle Ditch Restoration project is currently in process to reduce the incidence of flooding along Stang and Oberlin Roads.

Residents can help alleviate storm water flooding issues and improve the quality of storm water flowing to Lake Erie. Consider the following:

- Call 440-988-5894 to report flooding along Township roads or in your basement
- Pick up non-biodegradable trash, particularly plastics
- Clean roadside curbs in front of your home
- Clear rear yard drain grates if present on your property
- Direct roof runoff to your lawn surface versus township roadside drainage
- Recycle automotive fluids at local retail outlets that accept the fluids
- Pick up pet waste when walking your dog
- Do not drive around "Road Closed" signs

Yard Waste Recycling Center & Extended Summer Hours

As a reminder to residents, the "Yard Waste Pile" that is located on the east side of Oberlin Road, directly across from the Township Hall/Garage, will be open until 8pm on the 2nd and 4th Tuesday of the month, which coincides with the Trustees Meeting nights. These extended hours will continue through the summer and early fall.

The yard waste pile is for disposing of your limbs, brush, lawn clippings, and leaves. Residents are reminded to please place your empty plastic bags in the 55-gallon drum at the center, or take bags with you.

The Amherst Township Board of Trustees provides the "Yard Waste Recycling Center" service because it feels that there is a significant need for it in the township. This is not a mandated service that the township must provide.

The township has limited resources so it staffs and maintains the site as best that it can. The hours Monday through Friday correspond to the hours when the Road Department is working. Saturday hours correspond to the hours when the Zoning Inspector is at the Township Hall. The extended hours on the 2nd and 4th Tuesdays correspond to nights when there are Trustee Meetings. At these times there is someone available to open and shut the yard waste site and to watch who enters. The township lacks the resources to staff the site independently for additional hours. Furthermore, the Saturday morning and Tuesday evening hours were added by the Trustees in recognition that many residents would have difficulty with the Monday thru Friday daytime schedule.

This service is not free. The township spends thousands of dollars each year to have the yard waste ground and hauled away. This is in addition to the wages paid to the Road Department to supervise the site, sort and pile the waste, and otherwise maintain the site. The hours the Road Department spends on the yard waste are hours spent away from the roads.

Ohio's Laws on Noxious Weeds

"Noxious weeds" are plants that can injure agricultural crops and livestock due to their invasiveness, toxicity and other harmful characteristics. They can also negatively impact people and ecosystems. Like most states, Ohio has established processes for minimizing the negative impacts of noxious weeds.

Designation of noxious weeds

The director of the Ohio Department of Agriculture conducts rulemaking to designate a plant as a prohibited noxious weed. The list of plants formally designated as "prohibited noxious weeds" is in the Ohio Administrative Code and can be viewed at:

Noxious weeds along public roadways

Ohio law requires counties, townships, and municipalities to cut or destroy all noxious weeds, brush, briers, burrs, and vines growing along roads and streets within their jurisdictions. Cutting of the vegetation must occur every year between June 1 and 20, August 1 and 20, and if necessary, September 1 and 20, or whenever it's necessary to destroy the vegetation to prevent or eliminate a safety hazard.

All expenses incurred for cutting or destroying the weeds shall be paid for by the entity that owns the roadway. The "Township Road Fund" pays for all township roads.

RESIDENTIAL PARKING

Township roads are not intended to be a parking lot.

We understand that residents are going to have visitors and there may not be enough spots in their driveway. This occasional parking on the street is acceptable. But there are too many people who are parking their vehicles on the street on a regular, daily basis. This makes it difficult for neighbors trying to back out of their drives and it restricts the free flow of traffic. It is of great concern when this restriction inhibits the movement of emergency vehicles as well as township vehicles that are trying to plow snow, salt, or patch the streets.

There has been discussion about putting in "limited / no parking" regulations to insure that the streets are clear. However, at this point the trustees are reluctant to adopt such regulations, which would be enforced by the Sheriff Department by the fining of township residents. The Trustees ask residents to voluntarily comply.

The preference is that people would park in the driveways, which most people do.

We appreciate your understanding and efforts to comply.

COMMERCIAL VEHICLE PARKING ON RESIDENTIAL STREETS PROHIBITED

On February 22, 2011, the Amherst Township Trustees passed a Resolution prohibiting the parking of commercial vehicles with a gross vehicle weight of 10,000 lbs. or greater on all Designated Roads. The list of designated roads can be viewed on the Township's website under the "Resolutions" section.

With public safety in mind, the Board of Trustees determined that it was necessary to prohibit Commercial Vehicle parking in order to reduce the mingling of commercial traffic with pedestrian traffic on streets without street lights and sidewalks. Further, it will eliminate the physical obstruction and the obstruction of view on township roads that is caused by parking these commercial vehicles on the roads. The Board of Trustees also wishes to limit truck traffic in residential neighborhoods, excessive wear and tear on township roads, and the loss of residential character, all caused by the traveling to park and the parking of commercial vehicles on those roads.

Violation of these regulations is a minor misdemeanor. The fines that are levied and collected under these regulations shall be paid into the township general fund.

Sheriff's Office Joins "Neighbors by Ring" App

Lorain County Sheriff Phil Stammitti announced his office has joined the "Neighbors by Ring" app in efforts to reduce crime in the county.

The app will allow the Sheriff's Office to inform the community of real-time crime and safety events. It allows the user to "see something, share something" directly with the Sheriff's Office.

The user has to provide permission to the Sheriff's Office through the app for the video. At no time will the Sheriff's Office be able to monitor live feeds from the users' device.

You do not need "Ring" devices to participate; anyone with any camera system can upload content to the "Neighbors by Ring" app. Lorain County residents are encouraged to spread the word and may download the app on mobile phones by texting "stay safe" to 555888.

Crime or suspicious activity may be reported at any time by calling the Lorain County Sheriff's Office at 440-329-3709 or 911 only in an emergency.

LCSWD MINI-GRANT

For the fourth year Amherst Township applied for and received \$5000 from the Lorain County Storm Water District (LCSWD) Mini-Grant. This funding is awarded on a "First-Come-First-Serve" basis for qualified storm water management projects and requires a 20% minimum financial match from the township.

Amherst Township will be using this funding towards the repair/replacement of six catch basins in Hidden Valley; two are located at 910 & 911 Moonstone Drive, two at 7270 Hidden Glenn, and two at the intersection of Deer Run and Hidden Glenn. Total estimated cost of this project is \$9200.

Deteriorating catch basins are causing erosion issues for adjoining properties and streets, allowing sediment to wash into the storm sewer system draining to the Beaver Creek watershed, causing loss of value and environmental concerns.

GRANT APPROVED

Amherst Township continues to apply for "Community Grants" through the Lorain County Storm Water District to help fund the township's Storm Water Management Program projects. These grants are offered each year to townships through a competitive application process to fix stormwater issues. The projects help protect and preserve stormwater control infrastructure as well as reduce the frequency and severity of flooding.

The Lorain County Commissioners recently approved six "Community Grants" which included the Storm Water Management Project for Amherst Township. This year's project is designated as "Engle Ditch Phase 3 Restoration Project".

When leaving a message, you should first state your name and number, then a brief description of why you are calling, followed by repeating your name and number. This will help ensure that your call is returned.

PERMITS REQUIRED

Residents are reminded that permits are needed for pools, decks, porches, patios, gazebos, fences, ponds, signs, garages, new construction, building additions, accessory buildings, and driveways. When a permit is obtained before the start of construction, the fee will be reduced by 50%. Be sure you or your contractor has obtained a permit. Payments must be made by check only. Cash is not accepted.

Please contact Remi Cerrone, Amherst Township Zoning Inspector for these permits. Office hours for the Zoning Inspector are from 8 a.m. to 11 a.m. on Mondays, Wednesdays and Saturdays. He can be reached at 988-5894. Voice Mail is checked daily.

Building Inspections are not required. recommended that residents hire own inspectors.

DRIVEWAY APRONS

Residents are also reminded that when a road project requires modification of a drive apron, as a general rule, the drive apron modification will be completed with the same material as the road project. maintenance of a drive apron is the responsibility of the property owner.

TELEHEALTH

"Telehealth" is the practice of treating patients via technology. Appointments can be completed by phone or computer; in person appointments are not necessary.

Medicare recently expanded coverage for beneficiaries to include "Telehealth" services from their providers. However, as "Telehealth" expands, so does the exposure to fraud.

Following are a few ways to protect yourself from "Telehealth" fraud:

- Call YOUR provider to schedule your "Telehealth" appointment.
- If you receive a phone call from someone offering you free testing, treatment, or supplies – It's a SCAM! Hang up!
- Protect your Medicare Card:
 Do not give out your Medicare number to anyone other than your doctor or health care provider.
- Review your Medicare Summary Notice (MSN) for improper billing and items that appear that you didn't order or receive.

Fraud Protection Tips: Facts Vs. Fiction

The economy may be shut down, but business is booming in the fraud arena. Americans are finding themselves at war with fraudsters. The following are just a few of the current frauds related to the COVID-19 pandemic according to the North Dakota's Senior Medicare Patrol (**SMP**):

• COVID-19 Prevention Pill and Cure:

This scam solicits investments in a company that pushes pills and cures, claiming they can cure patients within two to three days. A scammer posted a video on an "Instagram account showing himself taking the pill and then walking into an area with COVID-infected individuals stating that he would not get the virus.

• Coronavirus Medical Kit:

of a fraud scheme, Operators published on their website, consumers access to World Health Organization (WHO) vaccine kits in exchange for a shipping charge of which consumers paid bv entering credit card information on the Understandably, Americans website. are desperate to find solutions to keep their families safe and healthy. Fraudsters are seeking to profit from fear and uncertainty by defrauding consumers and committing identity theft.

• Virus Pesticide:

A company claimed that it could reduce the risk of COVID-19 infections in public spaces with the new generation of fungicide which reduces transmissions by 90%. Upon investigation, it was found that the fungicide was being imported from Japan and was illegal to distribute in the U.S.

• Covid19/Genetic Testing:

company marketing medically unnecessary genetic testing schemes saw the pandemic as an opportunity to existing expand the on scam. capitalizing on people's fears and using the national emergency for financial The tests were bundled with expensive respiratory pathogen panels with the company receiving kick-backs on a per-test basis. The company marketed the hard to obtain COVID-19 tests, conspiring to bilk citizens of a valuable resource that was in high demand by the medical community.
