I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OR LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or loss or damage to property owned by me, as a result of participation in these activities.

I hereby RELEASE, WAIVE, DISCHARGE, AND from any and all liability, claims, demands, action and causes of actions whatsoever arising of or related to any loss, damage or injury, including death, that may be caused or sustained by me, or to any property belonging to me or property belong to others or AIA or the Owner, while participating in the physical activities, or while on or upon the premises where the activities are being conducted. I also hereby PROVIDE A COVENEANT NOT TO FILE SUIT(s), JUDGEMENTS, or LIENS AGAINST ARMSTRONG INDOOR ATHLETICS, LLC. (AIA), AIA'S MEMBERS, AND THE PROPERTY OWNER.
