THE UNITED STATES ATTORNEY CHARGES THAT:

COUNT ONE

(Vio. 18 U.S.C. §§ 1532(19), 1538(a)(1)(G) and 1540(b)(1))

On or about February 19, 2004, in Wagonhammer Creek on the Salmon National Forest near North Fork, in the District of Idaho, Defendant TIMOTHY B. SUNDLES did knowingly and unlawfully take, by attempting to harm and kill a threatened species; that is, a gray wolf (*Canis Lupus*), by then and there baiting said protected wildlife with poisonous "meatballs;" in violation of

the Endangered Species Act of 1973, in violation of Title 16, United States Code, Sections 1532(19), 1538(a)(1)(G) and 1540(b)(1).

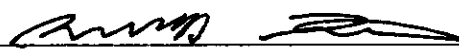
COUNT TWO

(Vio. 36 C.F.R. §§ 261.9(f) and 261.1b)

On or about February 19, 2004, in Wagonhammer Creek on the Salmon National Forest near North Fork, in the District of Idaho, TIMOTHY B. SUNDLES did use a pesticide, to-wit: aldicarb sold as Temik, without authorization, by then and there placing said pesticide in poisonous "meatballs" on said Forest Service grounds; all in violation of Title 36, Code of Federal Regulations, Sections 261.9(f) and 261.1b.
