ACCORDINGLY, the court has adjudicated that the defendant is guilty of the following offense(s):



UNSUPERVISED PROBATION

The defendant is hereby placed on unsupervised probation for a term of 5 years.

While on probation, the defendant shall not commit another federal, state, tribal, or local crime.

The defendant shall make special assessment and restitution payments as ordered by the Court and is required to notify the Court of any material change in the defendant's economic circumstances that might affect the defendant's ability to meet these monetary obligations.

The defendant's hunting privilege's will be suspended worldwide effective immediately, for 4 years in accordance with the Interstate Wildlife Violator Compact

The defendant shall forfeit the firearm, or parts thereof that was used to illegally take the grizzly bear.

The defendant shall serve 200 hours of community service at least 40 hours per year for term of probation.

FINANCIAL PENALTIES

The defendant shall pay the following total financial penalties in accordance with the schedule of payments set out below.

FINE, RESTITUTION, and COMMUNITY SERVICE PAYMENT

The fine and/or restitution includes any costs of incarceration and/or supervision. The fine, which is due immediately, is inclusive of all penalties and interest, if applicable. Restitution, if applicable, is for response, assessment, restoration and monitoring activities for injuries to park system resources.

The total fine and other monetary penalties shall be due in full immediately.
