# EMERGENCY MOTION TO CORRECT DOCKET ENTRY AND DOCUMENT CONTINUING OPPRESSION UNDER COLOR OF OFFICE

Plaintiff Michael Anderson, Pro Se, moves this Honorable Court for an immediate, emergency order to correct the official court docket and documents this continuing act of oppression, pursuant to the Court's inherent power and **SCRCP Rule 60(b)(3)**.

## I. STATEMENT OF FACTS AND CONTINUING OPPRESSION

1. On November 6, 2025, Plaintiff filed the "**EMERGENCY MOTION ACTING ON THE COLOR OF OFFICE: STRIKE, SANCTION, REMEDY FRAUD UPON THE COURT, AND CONTINUE PROCEEDINGS**".
2. The Clerk's office accepted payment for the motion (Filing Fee of \$75).
3. The official docket, dated November 6, 2025, fails to record the motion under its proper title, omitting the core claim of "**ACTING ON THE COLOR OF OFFICE**".
4. Instead of one entry, the Clerk fragmented the single filing into three generic, separate entries: "Motion to Void Post-Suppression Orders/Filings," "Motion for Immediate Ruling on Suppressed Default Jud," and "Motion for ADA Accommodations".

5. This action is not a technical error but serves as **direct, current, and irrefutable evidence of the continued, willful scheme of mislabeling and suppression** alleged in Section II.A.2 of the underlying Emergency Motion.
6. The deliberate omission of the phrase "**ACTING ON THE COLOR OF OFFICE**" is an immediate administrative act designed to conceal the gravity of the constitutional and public corruption claims from the Presiding Judge and the public record. **This obstruction constitutes a continuation of the oppression under color of office (42 U.S.C. § 1983).**

## II. RELIEF REQUESTED

Plaintiff respectfully requests the Court order the Clerk of Court to:

1. Immediately **CORRECT THE DOCKET ENTRY** to display a single motion entry using the exact, complete title: **EMERGENCY MOTION ACTING ON THE COLOR OF OFFICE: STRIKE, SANCTION, REMEDY FRAUD UPON THE COURT, AND CONTINUE PROCEEDINGS.**
2. **VOID** the two duplicate, fragmented docket entries created on November 6, 2025.
3. Grant all further relief necessary to preserve the integrity of the record.
