**MOTION**

Plaintiff, Michael Anderson, Pro Se, respectfully moves this Court for emergency relief. This motion is grounded upon the record evidence of **DOCKET BACKDATING, DOCKET MANIPULATION**, the preservation of Plaintiff's constitutional **JURY TRIAL DEMAND**, and Plaintiff's damages claim of **\$3,974,000**.

## Attorney Backdating & DOCKET MANIPULATION

The docket falsely shows Parker Brown as **attorney of record** as of **June 24, 2025**. In truth, Plaintiff filed a motion that day which was **suppressed and backdated**, and Parker did not appear until **June 25**, as proven by **NEFs (Exhibits QQ, RR)**.

On **July 31, 2025**, the Clerk solicited Parker again for the **August 26 hearing**, where the judge ultimately **vacated the Master-in-Equity referral**. Although adjourned, Parker nevertheless **participated despite not being attorney of record**, further confirming deliberate **DOCKET MANIPULATION**.

Importantly, Plaintiff has preserved a **voicemail from Senior Clerk Doris O'Hara (Exhibit EE)**, together with Plaintiff's follow-up call, confirming that she and her staff had **double-checked and triple-checked Plaintiff's file**. This independent evidence proves the irregularities are not conjecture but are admitted at the highest level of the Clerk's office.

---

## Ongoing Fraud and Grounds for Prohibition

These manipulated entries — the June 24/25 backdating, the Parker false appearance, the Master-in-Equity referral, the July 31 solicitation, and the August 26 hearing — all obstruct Plaintiff's rights, delay his **JURY TRIAL DEMAND**, and undermine his **\$3,974,000 CLAIM**.

## Applicable Law

- **Ex parte Knox, 3 S.C. 338 (1872)** – **FRAUD UPON THE COURT** vitiates all proceedings.
  - **Chewning v. Ford Motor Co., 354 S.C. 72, 579 S.E.2d 605 (2003)** – Clerks cannot exercise judicial power.
  - **State ex rel. Ritter v. Bailey, 232 S.C. 192, 101 S.E.2d 503 (1957)** – Writs of **MANDAMUS** and **PROHIBITION** restrain unlawful judicial/clerical acts.
  - **Rule 79(a), SCRPC** – Clerk's duty to keep docket is ministerial; any **DOCKET MANIPULATION** is ultra vires and constitutes **FRAUD UPON THE COURT**.
  - **Rule 38, SCRPC** – **JURY TRIAL DEMAND** must be preserved.
  - **Rule 60(b)(3), SCRPC** – Relief for fraud or misconduct.
  - **S.C. Const. Art. I, § 22** – **JURY TRIAL** guaranteed.
  - **18 U.S.C. § 1506** – Falsification of records; persuasive authority against **DOCKET BACKDATING**.

## RELIEF REQUESTED

WHEREFORE, Plaintiff respectfully prays that this Court:

1. Recognize Defendants' default;
2. Grant summary judgment in Plaintiff's favor;
3. Enter judgment for damages of **\$3,974,000**;
4. Preserve Plaintiff's constitutional **JURY TRIAL DEMAND**;
5. Issue writs of **MANDAMUS** and **PROHIBITION** to prevent further **DOCKET MANIPULATION, DOCKET BACKDATING, and FRAUD UPON THE COURT**, as documented in Plaintiff's filings and confirmed by **voicemail evidence from Senior Clerk Doris O'Hara (Exhibit EE)**.


