

- Exhibit A – Unsolicited Letter of May 29, 2025 from Defense Counsel to Circuit Court Confirms dismissal in Magistrate Court and acknowledges case was not properly before Circuit Court.
- Exhibit B – Complete Docket Sheet – Case No. 2025-CP-21-01381 Shows Defendants flagged as “Inactive” on June 9–10, 2025; premature closure on September 10, 2025; Plaintiff's timely motions unaddressed.
- Exhibit C – Florence County Court Roster – June 2, 2025 Confirms no hearing for Plaintiff's case was scheduled before Judge Seals, contradicting docket entries.

COMES NOW the Plaintiff, Michael Anderson, pro se, and respectfully objects to the August 26, 2025 hearing on referral to the Master-in-Equity, and supplements his pending Emergency Petition before the Supreme Court. In support, Plaintiff shows the following:

1. No June 2, 2025 Hearing Occurred – The docket reflects a hearing before Judge Seals on June 2, 2025. However, the Florence County roster for June 2, 2025 contains no listing for this case. No such hearing ever occurred, and any order or referral arising from it is fraudulent and void.
2. Defendants Marked Inactive – The Clerk's docket shows Defendants William B. Eaddy and Gloria Brown flagged as “Inactive” as of June 9–10, 2025. Defendants did not respond and are in default, yet the Clerk advanced the case improperly.
3. Premature Case Closure – On or about September 10, 2025, the Clerk prematurely closed the case file despite Plaintiff's pending motions, including for summary judgment and fraud upon the court, thereby obstructing access.
4. Unsolicited May 29, 2025 Letter – Defense counsel transmitted an unsolicited letter to the Circuit Court on May 29, 2025, acknowledging dismissal in Magistrate Court. This confirms the case was not properly before the Master-in-Equity.

5. Supreme Court Emergency Petition Pending – Plaintiff has filed an Emergency Petition in the Supreme Court (Case No. 2025-001601) raising these same issues. This filing preserves the record in the Circuit Court while notifying the Supreme Court of additional supporting evidence.

WHEREFORE, Plaintiff objects to the August 26, 2025 hearing, requests that referral to the Master-in-Equity be stricken as void, and that this case be restored to the Circuit Court for proper adjudication of Plaintiff's pending motions and default judgment.




