Assumption of Risk, Release, and Hold Harmless

Assumption of Risk

I am aware that my child or ward's participation in the Mount Olive Community Bible Church (MTOCBC) Sports & Scripture Camp activities involves risks, dangers, and hazards. The risks, dangers, and hazards, include but are not limited to: loss of balance; difficulty or inability to control one's speed and direction; variation or changes in the playing surface (such as rocks or gravel); failure of equipment; changing weather conditions; exposure to temperature extremes or inclement weather; collision with other participants or players; failing to play safely or within the limitations of one's own abilities; exposure to communicable diseases; and negligence on the part of the instructors or supervisors supplied by MTOCBC. While rules, supervision, equipment, parental oversight, and personal discipline may reduce these risks, the risks of serious injury, illness, or death do exist.

I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation and/or in the program itself, I will remove my child from the participation and alert MTOCBC to the concern immediately.

I AM AWARE OF THE RISKS, DANGERS, AND HAZARDS ASSOCIATED WITH PARTICIPATION IN MTOCBC ACTIVITIES AND I FREELY ACCEPT AND ASSUME ALL SUCH RISKS, DANGERS, AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, ILLNESS, DEATH, PROPERTY DAMAGE, OR LOSS RESULTING THEREFROM.

Release of MOCBC from Liability and Agreement to Indemnify and Hold Harmless

IN CONSIDERATION OF my child/ward, _____ being allowed to participate in any way in MTOCBC Camp activities, the undersigned acknowledges, understands, and agrees that:

1. I myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS MTOCBC CAMP**, their directors, officers, officials, agents, employees, volunteers, instructors, trainers, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct MTOCBC CAMP events ("Releasees"), **WITH RESPECT TO ANY AND ALL claims, causes of action, suits, and demands whatsoever, of any nature, in law or in equity, arising out of PERSONAL INJURY, ILLNESS, DISABILITY, DEATH, or for loss or damage to person or property incident to my child's involvement or participation in all MOCBC CAMP programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.**
2. I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, **HEREBY INDEMNIFY AND HOLD HARMLESS** all the above Releasees from any and all claims or liabilities incident to my involvement or participation in these programs, **EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law; and form**
3. I, the parent/guardian, assert that I have explained to my child/ward: the risks of the activity, his/her responsibilities for adhering to the rules and regulations, and that my child/ward understands this agreement to the fullest of his or her cognitive abilities.

I, FOR MYSELF, MY SPOUSE, AND CHILD/WARD, HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
