

- ⇒ Six Flags charges a processing fee of \$8.99
- ⇒ No charge for Disneyland or Universal.
- \Rightarrow \$50.00 fee charged for all returned checks
- ⇒ Have your COPMEA cards ready when making purchases
- ⇒ Tickets for monthly events are restricted to your membership
- ⇒ Take your old membership card to the COP-MEA Office for replacement if your social security number appears on the card
- ⇒ Report any membership and address changes to the COPMEA Office

CITY OF PHOENIX EMPLOYEE MONTHLY MEMBERSHIP
